IN DECATUR TOWNSHIP : :

TO THE HONORABLE W. WALLACE SMITH, PRESIDENT JUDGE OF SAID COURT:

The Petition of the Road Supervisors of Decatur Township,
Clearfield County, Pennsylvania, respectfully represents:

(1). That your petitioners desire to accept and adopt this
Township Highways and Streets; three streets in the village of
Gearhartville in said Township.

(2). That your petitioners at a regular meeting on the 2nd
day of August 1937, adopted and approved a resolution accepting
the following streets in the village of Gearhartville, Decatur
Township, Clearfield County, Pennsylvania, as Township Highways and
Streets:

One: Beginning at corner of Samuel Sleigh's property
and State Highway thru Gearhartville; thence in
an Easternly direction to the Township Road lead-
ing to Baltic. And being fifty (50) feet wide.

Two: Beginning at the State road at corner of Old Cuba
School property; thence in and Easternly direction
to the proposed road designated as No. three as
hereinafter described. And being fifty (50) feet
wide.

Tree: Beginning at the corner of John Hindil property and
State Highway; thence in a Northernly direction to
Enoch Perks, Sr., and John Winters' properties.
And being fifty (50) feet wide.

Four: Beginning at the corner of John W. Johnson property
and State Highway; thence in a Northernly direction
to William Entwistle property. And being fifty (50)
feet wide.

(3). That a copy of said resolution is attached hereto and made
a part of this petition.

(4). That said adoption and acceptance of said streets is in
accordance with the Act of Assembly of May 1, 1933, P. L. 103 as
amended by the Act of July 18, 1935, P. L. 1308.

WHEREFORE your petitioners respectfully pray that your Honorable Court will approve the adoption and acceptance of said described streets in the Village of Gearhartville, Decatur Township, Clearfield County, Pennsylvania, as Township Highways and Streets





R E S O L U T I O N

BE IT HEREBY RESOLVED: That the Board of Supervisors of Decatur Township, accept and adopt as Township Highways and Streets, the following streets which were dedicated as such in the plot known as the village of Gearhartville:

One: Beginning at corner of Samuel Sleigh's property and State Highway thru Gearhartville; thence in an Easternly direction to the Township Road leading to Baltic. And being fifty (50) feet wide.

Two: Beginning at the State road at corner of the Old Cuba School property; thence in an Easternly direction to the proposed road designated as No. Three as hereinafter described. And being fifty (50) feet wide.

Three: Beginning at the corner of John Hindil property and State Highway; thence in a Northernly direction to Enoch Perks' Sr., and John Winters' properties. And being fifty (50) feet wide.

Four: Beginning at the corner of John W. Johnson property and State Highway; thence in a Northernly direction to William Entwistle property. And being fifty (50) feet wide.

Said streets are to be maintained as Township Highways by the Road Supervisors of Decatur Township.


