The Petition of the Road Supervisors of Lawrence Township,  
Clearfield County, Pennsylvania respectfully represent.

1. That your petitioners desire to accept and adopt as  
a township highway and street, Elizabeth Street, as dedicated  
on the Reed Addition to the Borough of Clearfield, which was  
dedicated as such on October 25, 1921 and recorded in the office  
of the Recorder of Deeds of Clearfield County, Pennsylvania in  
Miscellaneous Book Volume 17, page 563; from the Borough line on  
said Street, West to the Susquehanna River.

2. That your petitioners at a special meeting on April  
17, 1937 adopted and approved a resolution accepting the said  
Elizabeth Street, being 50 feet wide, on the plot of Reed Addition  
to Clearfield Borough as a Township highway and street, from the  
Borough line West to the Susquehanna River.

accordance with the Act of Assembly of May 1st, 1933 P.L. 103  
as amended by the Act of July 18th, 1935 P.L. 1308.

RESOLUTION

BE IT HEREBY RESOLVED, that the Road Supervisors of Lawrence Township accept and adopt as a Township Highway and Street the following street which has been dedicated as a public highway in the said Township: Elizabeth Street beginning at borough line of Clearfield Borough and then proceeding along said Elizabeth Street in a Westerly direction to the Susquehanna River, being a 50 foot wide street.
