in Lawrence Township :

TO THE HONORABLE W. WALLACE SMITH, President Judge of said Court:

The petition of the Road Supervisors of Lawrence Township Clearfield County, Pennsylvania, respectfully represent:

1. That your petitioners desire to accept and adopt as township highways and streets; various streets which were dedicated as such by D. R. Woolridge on the plot of D. R. Woolridge Addition to Clearfield, Pennsylvania, recorded on October 28, 1925, in the office of the Recorder of Deeds in Clearfield County, Pennsylvania in Miscellaneous Book Volume 27, page 256.

2. That your petitioners at a ~~regular~~ meeting on March 5, 1938, adopted and approved a resolution accepting the following streets on the plot of D. R. Woolridge addition to Clearfield, Pennsylvania, as Township highways and streets:

ONE. Reighard Street, from High St. to Bradford St. 40 feet Wide

TWO. Bradford St. from Reighard St. to Burchfield St.  
40 feet wide

THREE. Burchfield St. from Byers St. to Summit St.  
40 feet wide

FOUR: Byers St. from Reighard St. North 820 feet to alley  
40 feet wide

3. That a copy of said resolution is attached hereto and made a part of this petition.

4. That said adoption and acceptance of said streets is in accordance with the Act of Assembly of May 1st, 1933, P. L. 103 as amended by the Act of July 18th, <sup>1935</sup> P. L. 1308.

Wherefore your petitioners respectfully pray that your Honorable Court will approve the adoption and acceptance of said described streets on the plot of D. R. Woolridge Addition to Clearfield, Pennsylvania, as Township Highways and Streets.

BE IT HEREBY RESOLVED, that the Road Supervisors of Lawrence Township accept and adopt as Township Highways and streets the following streets which have been dedicated as public highways in the said Township:

ONE: Reighard Street, from High St. to Bradford St.

40 feet wide.

TWO: Bradford St. from Reighard St. to Burchfield St.

40 feet wide.

THREE: Burchfield St. from Byers St. to Summit St.

40 feet wide.

FOUR: Byers St. from Reighard St. North 820 feet to alley

40 feet wide.

Said streets are to be maintained as Township Highways by the Road Supervisors of Lawrence Township.
