O R D E R

WHEREAS by proceedings to No. 11 September Sessions, 1938, a Board of Viewers was appointed and reported favorably to the establishment of a public highway in Greenwood Township, Clearfield County, leading from the State Highway Route No. 62 (between Mahaffey and Clearfield) near the J.R.Dickie gasoline station to and across the Susquehanna River, and thence to a point on the public road to Ansonville near the Curry Run railroad station of the New York Central Railroad, which report has, except so far as it concerns the bridge included therein, been this day absolutely confirmed;

AND WHEREAS there was included in the said highway so found to be necessary a bridge across the Susquehanna River, in the erection of which the Viewers were of opinion that the present private bridge formerly used as the bridge of the Curry Run Railroad and owned by the Irvin and Mitchell Estates, should be used, but required to be rebuilt and repaired to change it from a railroad to a public road bridge;

AND WHEREAS the Board of Viewers by a majority thereof reported that in their opinion the said bridge was necessary but that the expense of purchasing and reconditioning the same for public use would be greater than would be reasonable for the Township to bear, and recommended that the same be accepted as a County Bridge, of which findings one of the Viewers disapproved;

AND WHEREAS following the filing of said Viewers' Report

the County Commissioners by resolution duly filed of record in said proceeding, as well as by Exceptions to the Viewers' Report, expressed their disapproval of the acceptance of the same as a County Bridge;

AND WHEREAS the recommendations contained in the Viewers' Report so far as concerned said bridge were submitted to the Grand Jury of Clearfield County at February 22, 1939, for their approval or disapproval, and in order that appropriate action might be taken with reference thereto, and said Grand Jury in its report duly filed has reported that in its opinion the said bridge is necessary for the convenience of the public, but that the same should not be accepted as a County Bridge but that the same should be taken over by the Township, and that the County Commissioners appropriate to Greenwood Township for assistance in the erection of said bridge the sum of \$1000.00;

AND WHEREAS by reason of the disapproval of the County Commissioners and of the Grand Jury said proceeding as to said bridge has failed so far as the object of making the same a county bridge is concerned, but has rendered it possible for said bridge to be erected as a part of the Township system of highways but to have a contribution thereto by Clearfield County in the sum of \$1000.00;


AND WHEREAS the approval of the Court is required in order that such proposed aid may be extended by the County Commissioners under the Act of Assembly of July 15, 1935, P.L. 1037, Section 1; 16 P.S. 755 (a);

NOW THEREFORE, in view of the premises recited, and in order that said bridge may be erected as a township bridge but with such proposed assistance to the extent of \$1000.00 by Clear-

field County, the Court hereby finds that a bridge is necessary at said point, and that the erection thereof will require more expense than it is reasonable that Greenwood Township alone should bear, and that the said projected bridge is a proper subject for assistance by Clearfield County to the extent of \$1000.00 without entering such bridge on record as a County bridge; and the report of the Grand Jury and recommendation with reference thereto are hereby approved and the Report of the Viewers is approved to the extent that said report is not inconsistent with the finding of the Grand Jury and this order.
