SIXTH: That the viewers awarded to the Creditors Committee of the estate of H.M.Irvin, deceased, the sum of two hundred (\$200.00) dollars as damages sustained by them in the condemnation of the bridge across the Susquehanna River.

SEVENTH: That the Creditors Committee of H.M.Irvin Estate are A.L.Hegarty, Coalport,Pa., John Y. Rafferty,Sr., Grampian,Pa., Don Miller, Grampian,Pa.

EIGHTH: That the Court by order dated the 25th day of February, 1939, approved the report of the viewers, such approval constituting confirmation absolute of the report, it having previously been approved nisi at September Sessions, 1938.

NINTH: That the Supervisors caused their attorney, Clarence R.Kramer to offer to the Creditors Committee the road district's check in the amount of two hundred (\$200.00) dollars in payment of the damages awarded; such offer was made by letter dated the 18th day of September, 1939, a separate copy of which was addressed to each member of the Committee at their respective addresses and deposited in the post office with postage pre-paid.

TENTH: That no response to said letter has been received either by the Road District or by their attorney.

ELEVENTH: That the Supervisors caused their attorney, Clarence R.Kramer to interview John Y.Rafferty, Sr. personally and Don Miller by telephone requesting them to accept the award of damages.

TWELFTH: That Messrs. Miller and Rafferty have refused to accept the said sum.

THIRTEENTH: That with the advent of fall and the approach of winter it is necessary that the bridge be put into travelable condition without delay. The Supervisors have been advised that their remedy is to cause the money to be paid into Court.

WHEREFORE, they pray your Honorable Court for permission to pay into Court the sum of two hundred(\$200.00) awarded the Creditors Committee of H.M Irvin Estate.

PETITION TO PAY MONEY INTO COURT

To the Honorable W. Wallace Smith, President Judge of said Court:

The petition of the Board of Supervisors of the Township of Greenwood, Clearfield County respectfully represents:

FIRST: That proceedings were instituted on July 15, 1938 to No. 11 September Sessions, 1938, to lay out a public road and bridge in Greenwood Township, Clearfield County, beginning at a point in Route No. 62 in the Village of Curry Run near the J.R. Dickie gasoline station and ending across the river at a point near the site of the New York Central Railroad Station.

SECOND: That pursuant thereto a view was had and a report made to your Honorable Court by the Board of Viewers on September 6, 1938 recommending the road and bridge as prayed for.

THIRD: That on February 25, 1939 exceptions to the Viewers' report as filed by the County Commissioners were discharged.

FOURTH: That at February Sessions, 1939, the subject matter of these proceedings so far as regards the bridge were submitted to the Grand Jury for action.

FIFTH: That the Grand Jury at the February Sessions, 1939 made a recommendation in favor of the bridge and of the granting of one thousand (\$1000.00) dollars by the County to the Township toward the cost thereof.
