TO THE HONORABLE THE JUDGE OF THE ABOVE NAMED COURT:

The petition of the undersigned, all of whom are residents, citizens and taxpayers of Sandy Township, Clearfield County, Pennsylvania, respectfully request your honorable Court to grant a re-review of the proceedings for the opening and laying out of a road leading from South Main Street Extension opposite the residence of P. S. Heberling, Westerly to corner of Northwood Avenue and Hand Street.

That said petition was filed June 19, 1942 and referred to Viewers who, by return filed to the Court of Quarter Sessions at December Sessions ¹⁹⁴²~~1938~~, found such road not necessary, and refused to open the same.

Petition for re-view was filed February 1, 1943 and referred to other Viewers, who by return made and on file for May Sessions of 1943, ordered the opening and laying out of said road.

Your petitioners respectfully object thereto, as the said road is at this time unnecessary, and in view of the financial condition of Sandy Township, will throw an excessive and grievous burden of taxation upon all of the residents of said Township. The said proposed road is not necessary or needed, as the area is now

served by many streets, roads and highways which are largely paved and improved. The proposed road will require the use of materials and labor now impossible to obtain due to war conditions and any convenience to a very small portion of the traveling public will be far less than the cost of construction.

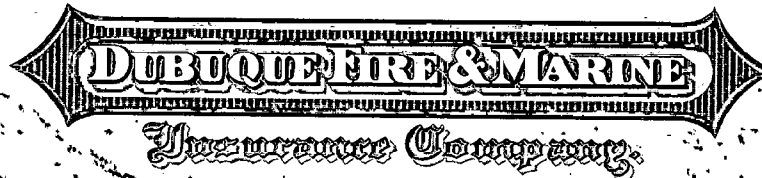
