TO THE HONORABLE W. WALLACE SMITH, PRESIDENT JUDGE OF THE ABOVE
NAMED COURT:

The petition of the Supervisors of Sandy Township, Clearfield County, Pennsylvania, respectfully represents:

1. That Miss A. D. Wayne, did, by a plot of a real estate development in Sandy Township, Clearfield County, Pennsylvania, on or about September 18, 1900, dedicate a certain street known as Arminta Street to the public and the plot of said real estate development was filed in the Recorder's Office of Clearfield County in Miscellaneous Book 58, page 525.
2. That said Arminta Street has been used by the public since that date and a number of dwelling houses are located upon said street, but said street was not accepted or made part of the public highway of the State of Pennsylvania, or of Sandy Township.
3. That in accordance with the requirements of the Act of May 1, 1933, P. L. 103, Article XI, paragraph 1147, as added to by the Act of July 18, 1935, P. L. 1299, paragraph 2, as amended by the Act of May 8, 1941, P. L. 39, paragraph 1, (53 Purdon's Statutes, paragraph 19093-1147), a resolution was passed by the Supervisors of Sandy Township on Saturday, August 7, 1943, accepting Arminta Street beginning where said Arminta Street intersects with State Highway Route No. 17,014, thence running in a Northerly direction until said Arminta Street reaches the City Line of the City of DuBois, as part of the public highway system. A duly certified and attested copy of

the said resolution, together with a map setting forth said street
is hereto attached and made a part hereof.

4. Your petitioners therefore pray your Honorable Court
to consent to the acceptance of the said Arminta Street by the
Supervisors as provided by said Act of Assembly aforesaid.

WHEREAS, the plot filed by Mrs. Rose Wayne in Clearfield County, Pennsylvania, in Miscellaneous Book 58, page 525 on the 6th day of August, 1943, being a plot originally surveyed for Miss A. D. Wayne on September 18, 1900, the following roads and highways were dedicated to public use and have been used by the public since on or about September 18, 1900; and

WHEREAS, Mrs. Rose Wayne has requested the acceptance of the said streets as public highways and in consideration thereof has released the Township of Sandy for all claims and demands for damages by reason of the acceptance, opening, grading or paving of the said streets; therefore be it

RESOLVED, that Arminta Street, beginning at a point where said Arminta Street intersects with the Township Road, now known as State Highway Route No. 17,014, thence running in a Northerly direction until said Arminta Street reaches the City Line of the City of DuBois, be and the same is hereby accepted as a public highway in part of the road system of the Township of Sandy. A map of the said Arminta Street so laid out being hereto attached and made a part hereof.


