To the Honorable F. Cortez Bell, President Judge of said Court:

The petition of the undersigned supervisors of the Township of Karthaus respectfully represents:

1. The Township Road, Route 752 is located in the Township of Karthaus and extends from Pottersdale southwestwardly and intersects Route 751.

2. At a point on said Township Road Route 752, approximately 3400 feet south of said intersection and extending southerly a distance of approximately 1000 feet, the earth on either side of said Township Road is to be excavated by a coal stripping operation operated by Cataract Coal Company, which desires at its own cost and expense, and agreeable to the undersigned supervisors of the Township of Karthaus, to remove the coal under said road.

3. Cataract Coal Company has agreed to maintain traffic over said route or over a temporary road in the nearby vicinity until such time as said coal has been removed, traffic to be maintained in a manner satisfactory to the State Highway Department and to the Supervisors of Karthaus Township.

4. Upon removal of all the coal under said road, said Cataract Coal Company has agreed to refill the area occupied by said Route No. 752, where the said coal has been removed, and to roll the same until it is ready for use by the traveling public and meets with State Highway specifications for township roads of this type.

5. In the opinion of your petitioners, the said coal

can be removed and traffic satisfactorily maintained as outlined above without any injury or inconvenience to the public.

6. Inasmuch as the coal on both sides of said road has been excavated by removing the overburden it would be an advantage to have the coal taken out from under the road and have that area refilled and rolled as provided above.

7. The removal of said coal as outlined above would not involve the taking of any additional territory for right of way.

8. Attached hereto is a print showing the Road Route No. 752, and the area proposed to be altered, changed or improved.

WHEREFORE, the undersigned supervisors of the Township of Karthaus respectfully pray your Honorable Court that the proposed change, alteration or improvement of said Township Road, Route No. 752, as set forth herein be authorized, without the formality of a view as provided by Act of Assembly of May 1, 1933, P.L. 103, Section 1115, applicable to Townships of the Second Class.







KARTHaus TOWNSHIP




Sketch showing section of Township road
