





and, therefore, praying the Court to appoint proper persons to view and vacate said road between the points mentioned, whereupon the said Court, upon due consideration had of the premises, do order and ap-

point from and among the County Board of Viewers Harry Reese, Benjamin Hughes and

A. B. Shaw who have been duly appointed by the said Court on the County Board of Viewers, and filed their oaths of office in the office of the Court of Common Pleas of the County aforesaid, as required by law and are, therefore, duly qualified to perform the duties of their appointment, with impartiality and according to the best of their judgment; are to view the said road, and after having viewed the same, if they, or a majority of them, do agree that there is no necessity for said road, they shall proceed to vacate the same as agreeably to the desire of the petitioners as may be, and make report thereof to the next Court of Quarter Sessions to be held in and for said County, stating particularly whether there is any necessity for said road, or whether the same should be vacated; and the reason why, together with a plot, or draft, thereof showing the courses and distances with reference to the improvements through which said road passes.

And in case the viewers aforesaid shall decide in favor of vacating said road, they shall obtain from the persons through whose lands the said road passes, or otherwise affected, or damaged, by the vacating of said road, releases from whatever damage they may sustain by the vacation of said road; and in case the owners of such lands, or persons affected, thereby refuse to release their claim to damages, the said Viewers shall assess the same, taking into consideration the advantages, as well as the disadvantages, arising from the vacation of said road; and make report of such assessment; which report they shall in like manner transmit to the next Court of Quarter Sessions, with the draft, or plot, aforesaid. In which said reports they shall state that they have been sworn, or affirmed, according to law, and that due and legal notice was given of the time when and the place where they would meet, to view said road and the time and place of hearing.


And that after the view and hearing above mentioned, the undersigned Viewers do agree that said

road has become useless, inconvenient and burdensome and is no longer necessary as a Public Road, beginning at its point of intersection with State Highway Route #53 in Beccaria Township; thence extending in a Westerly direction for a distance of about one mile to its point of intersection with State Highway Route #17023 in said Township. That the road in question is narrow and very steep at some places and due to stripping operations along said road, which come within a few feet from the right of way of said road, with high spoil piles on one side and deep declivities on the other, and due to its present location and state of repair, makes said road extremely dangerous for travel and at present is being used almost exclusively for the hauling of coal from stripping operations in the vicinity of said road.

At the hearing it was brought to the attention of the Viewer's that any person living on the Cyrus Bloom place (now unoccupied) would have no outlet to the main road, if the Township Road in question, were vacated and abandoned, and further that the stripping operations near the Cyrus Bloom place would have no outlet to the State Highway Route #17023, leading from Irvona to Ansonville, Penna.

Wherefore in order to establish an outlet and to create no hardship on those persons now using or who may hereafter use said Township Road which

your Viewer's recommend be vacated and abandoned, it is further recommended by your undersigned Viewer's that a portion of said road be retained and established as a Private Road by the Court, beginning at the Cyrus Bloom place thence extending in a Westerly direction for a distance of 1800 feet to the State Highway Route #17023.



and that a plan, or draft, of said road to be vacated showing the courses and distances, and over whose property the said road passes, is hereto attached and made a part hereof.



N. B.—If the viewers believe the parties are not entitled to damages, taking into consideration the advantages as well as the disadvantages of the road, they will report to that effect.



REPORT AND RESOLUTION

NOW, We, Joseph Young, Wallace Owens and Joseph Thompson, Supervisors of Lawrence Township, do make, report and resolve in favor of the adoption and opening of the road as prayed for in the petition as follows:

(2) The original petition was dated September 20, 1949, signed by Russell Clark, William Pritts, Patrick Collins, Floyd Shaffer, Mrs. Sophie Haversack, William H. Graham and Miles C. Appleton, and upon the filing of the same the Supervisors caused notice to be given and held a meeting for hearing on October 1, 1949; that notice of said petition was also served on W. Wallace Smith, owner or co-owner of a large part of the property abutting on the proposed road; that the hearing on October 1, 1949 was attended by all of the petitioners except Floyd Shaffer and Sophie Haversack, and also by W. Wallace Smith, a property owner; and it appeared that said W. Wallace Smith and his co-owner, Frank W. Short, agreed to the road proposed;

That at said hearing, the Supervisors decided primarily upon the exercise of their power to adopt said road as prayed for but adjourned the hearing to the First Saturday of November next in order to permit the petitioners to have a survey and draft made and to submit the same together with more formal petition for action.

That at the continued hearing on November 5, the additional petition and draft were filed and are attached hereto along with the original

petition and also a certificate of the present ownership of properties abutting on said road;

That the proposed road is an old road which has been a portion of a series of roads leading from Roosevelt Avenue, a well improved highway on the Plan of the Steel & Iron Works Addition to Clearfield, across said Plan to the residence of Russell Clark; that said old road does not follow the streets and alleys as shown on the record plan but appears to have been laid out according to the contours of the ground which is a hillside; that said portion of road consisting of the two parts as described is a portion of a larger series of roads which were used for many years for the hauling of coal and produce from the Russell Clark farm as well as by the public generally; that said portions of said road as now prayed for eliminate any parts of said road heretofore used for the hauling of coal or produce but which were of benefit only to one or more of the individual petitioners, so that the portion now prayed for and approved herein is limited to the portion needed by all of said petitioners and for public use generally.

That said road appears to have been used for so long a time, upwards of 21 years, that it was contended by the petitioners and acquiesced in W. Wallace Smith, owner of a larger number of the lots as well as the beds of the streets and alleys on the Plan of lots; that said road had become established by said use and the supervisors believe that the same is so dedicated to public use;

That many of the lots sold in the vicinity show no signs of occupation upon the ground which is largely covered with brush and a number of said lots appear to have been originally purchased but apparently abandoned; that the list attached shows the present ownership thereof as nearly as may be ascertained practically; and that notice has been given to the several owners abutting on said road as appears from the statement of the Secretary of this

Board attached hereto;

NOW THEREFORE BE IT RESOLVED that the Supervisors of Lawrence Township hereby approve the prayer of the petition and hereby ordain and adopt and lay out as a public road of the township the two portions of road described in the petition and being as follows:

ROAD #1

BEGINNING at a point at the west side of Roosevelt Ave., a 60 ft. street, said point being located 560 ft. in a northerly direction from an iron pipe driven where the west side of Roosevelt Ave., extended, intersects the southwest side of McPherson St., and the northwest side of Robinson St. Said pipe being the northeast corner of Block 17 in the plan of the Steel & Iron Works Addition to Clearfield, Pa.; thence by center line of existing road the following courses and distances, North 72 deg. 15 min. west 75 feet to an intersection with the road leading to the right of property of M. J. Tornatore; thence south 76 deg. west 193 feet; thence north 86 deg. 20 min. west 115 feet; thence north 46 deg. 50 min. west 130 feet; thence north 24 deg. west 120 feet to a point near the intersection, on the right, with a public road leading to property of Mrs. Sophie Haversack; thence south 54 deg. 45 min. west 106 feet; thence south 39 deg. 213 feet to a point near the intersection on the left, with a road leading to property of Pat Collins; thence north 85 deg. 45 min. west 228 feet; thence south 66 deg. 15 min. west 195 feet to a point at line of land of Russell Clark and road on the left leading to properties of Miles Appleton and William Graham.

ROAD #2

BEGINNING at a point westerly 633 feet from west side of Roosevelt Ave., identified in description of Road #1 as its intersection with a road leading to property of Mrs. Haversack; thence north 69 deg. 15 min. west 194 feet; thence north 82 deg. 15 min. west 181 feet to a point near the southeast corner of dwelling of Mrs. Haversack; thence south 88 deg. 45 min. west 169 feet to a point at a spring; thence north 43 deg. 45 min. west 47 feet to a point over an 18 inch corrugated pipe (formerly a wooden bridge) under this road, and in the area designated as a 30 ft. alley in the before mentioned plan of the Steel & Iron Works Addition.

That said road shall have a width of thirty-three (33) feet consisting of sixteen and one-half ( $16\frac{1}{2}$ ) feet measured at right angles on either side of the center line of the present traveled roadways.

That no damages shall be allowed; all persons whose property is affected having waived the same in this proceeding or because of the long establishment of said road.

That this report be filed in the office of the Clerk of Quarter Sessions as required by law and that notice be given to the several persons interested and also publicly as required by law, and that such further proceedings be taken as may be so required.

That the notice referred to in the preceding paragraph shall fix the 19<sup>th</sup> day of November, 1949, at the Supervisors' office in Clearfield, Pa., as the time and place when this matter will be finally considered by the Supervisors; and that if no objection or request of further hearing shall appear at that time, this report and resolution shall be filed in the Office of the Clerk of Quarter Sessions of Clearfield County.





The petition of the undersigned respectfully represents:

Your petitioners have heretofore, on September 20, 1949, filed their petition to have a road opened from Roosevelt Avenue to the Russell Clark residence; and in pursuance thereof notice was given to interested parties and a hearing held before the Supervisors on October 1, 1949; that said hearing was continued to permit the petitioners to have a draft of the proposed road made by a surveyor and to present said draft together with a proper discription of the proposed said road and to take such other steps as might be required for formal action by the Supervisors.

Your petitioners, therefore, supplement their petition heretofore filed as follows:

Your petitioners labor under inconvenience for want of a public road and therefore pray the Supervisors to lay out and adopt the public road herein described;

That the petitioners, except Russell Clark, are residents of the village of Hyde City and particularly of various numbered lots in Blocks on the plan of the Steel & Iron Works Addition to Clearfield, also known as Hyde City; that said plan appears on the records in the Recorder's Office of Clearfield County and contains various streets and alleys dedicated to public use; that Russell Clark is the owner of a farm adjoining said plan of lots.

That in the section where your petitioners reside, the streets and alleys have not been actually constructed in accordance with the plan but that certain roads have been used by the public or by property owners for upwards of twenty (21) years; that said road as actually used affords a better grade road than could be obtained by following the streets and alleys of the plan;

That attached hereto is a section of the plan of the Steel & Iron Works Addition upon which is shown/roads in question, together with points and improvements surrounding or in connection with them as surveyed and drafted by H. F. Van Valzah, C. E.

Your petitioners, therefore, pray that the following portions of said old road be adopted and accepted as a public road of Lawrence Township:

ROAD #1

BEGINNING at a point at the west side of Roosevelt Ave., a 60 ft. street, said point being located 560 ft. in a northerly direction from an iron pipe driven where the west side of Roosevelt Ave., extended, intersects the southwest side of McPherson St., and the northwest side of Robinson St. Said pipe being the northeast corner of Block 17 in the plan of the Steel & Iron Works Addition to Clearfield, Pa.; thence by center line of existing road the following courses and distances. North 72 deg. 15 min. west 75 feet to an intersection with the road leading to the right of property of M. J. Tornatore; thence south 76 deg. west 193 feet; thence north 86 deg. 20 min. west 115 feet; thence north 46 deg. 50 min. west 130 feet; thence north 24 deg. west 120 feet to a point near the intersection, on the right, with a public road leading to property of Mrs. Sophie Haversack; thence south 54 deg. 45 min. west 106 feet; thence south 39 deg. 213 feet to a point near the intersection on the left, with a road leading to property of Pat Collins; thence north 85 deg. 45 min. west 228 feet; thence south 66 deg. 15 min. west 195 feet to a point at line of land of Russell Clark and road on the left leading to properties of Miles Appleton and William Graham.




