

ORDER OF COURT

And now, August 12, 1946, the foregoing Petition having been presented, read and considered, and it appearing to the Court that the change or alteration of the said Township Road No. 17611 in Bradford Township, Clearfield County, Pennsylvania, is to be made without cost to the said Township or to the Road District thereof, and it appearing further that the change is being made with the full consent and agreement of the property owners affected thereby, the said change is hereby approved by the Court and the Supervisors of the Road District of the Township of Bradford are hereby authorized to vacate a portion of Township Road No. 17611 in Bradford Township and to relocate the same as more fully set forth in the foregoing Petition, without the formality of a view and upon the completion of the new part or portion of the said road, the same shall constitute a part of Township Road No. 17611 in Bradford Township for public use and the old part or portion of the said road shall be vacated as a part of the Public Road System of the Road District of the Township of Bradford, Clearfield County, Pennsylvania.



P E T I T I O N

To the Honorable F. Cortez Bell, President Judge of the said Court:

The petition of C. O. English, George F. Wilson and Guy B. Graffius respectfully represents:

- (1). That your petitioners are the Supervisors of Bradford Township, Clearfield County, Pennsylvania.
- (2). That your petitioners are desirous of vacating a portion of an existing Township Road No. 17611 located in Bradford Township, Clearfield County, Pennsylvania, and of re-locating the same.
- (3). That attached hereto and by reference incorporated herein is a map showing the proposed re-location of the said Township Road and also showing the location of the existing Township Road which it is the desire of your petitioners to vacate.
- (4). That it is the desire of your petitioners to vacate that portion of the existing Township Road which lies between station P.C. $6\frac{1}{2}$ 33.5 and station P.T. $12\frac{1}{2}$ 17.5B=Station $12\frac{1}{2}$ 23.2A, this being a piece of road running from station P.C. $6\frac{1}{2}$ 33.5 east 234.2 feet to a point and then north 41° east 380.5 feet to station P.T. $12\frac{1}{2}$ 17.5B=Station $12\frac{1}{2}$ 23.2A.
- (5). That it is the desire of your petitioners to re-locate the said Township Road between the said stations in accordance with the proposed re-location shown on the attached map, to wit: the relocated road shall begin at station P.C. $6\frac{1}{2}$ 33.5 and shall continue on a 13° curve (having a tangent of 345 feet and an

angle of tangents of 76°) for a distance of 584 feet to station P.T. 12-17.5B = station 12-23.2A.

(6). That your petitioners have entered into an agreement with Shannon Land and Mining Company, a corporation having its office and principal place of business in Bigler, Clearfield County, Pennsylvania, wherein the said company has agreed with your petitioners that the change or alteration of the aforesaid portion of the Township Road shall be made at the cost and expense of the said company and that the proposed vacation and re-location will be without expense to the Township of Bradford.

(7). That the portion of the said road which is proposed to be re-located lies entirely within the boundaries of the property of C. W. Peters and Ethel Peters, his wife, and A. John Peters and Boyd G. Peters, and that the said property owners are the only persons affected by the proposed vacation and re-location and that all of the said persons have agreed that the said vacation and re-location shall be made without the formality of a view and have released the Supervisors and the said Township of and from any and all claims for damages which they might have against them as a result of the proposed vacation and re-location, and that the said release is hereto attached.

(8). That the proposed re-location results in an improved grade and in the elimination of a sharp turn and that your petitioners are, therefore, of the opinion that it is for the best interest of the Township that it be made.

WHEREFORE, it is the prayer of your petitioners that the part or portion of Township Road No. 17611 as described in the foregoing petition may be vacated and that the same may be relocated as set forth in the foregoing petition without the formality of a view and with the approval of your Honorable Court in accordance with the tenor of the Act of May 1, 1933,
