The petition of the undersigned Supervisors of the Township of Chest, County of Clearfield and State of Pennsylvania, respectfully represents:

1. That a public road was laid out by authority of law extending from ~~Intersection on Route 170/18 at Clyde Stivers~~ in a northerly direction to a point on the Jordan Township line near ~~George May's property line~~ in Chest Township, Clearfield County, Pennsylvania, which said public road was taken over by the Highway Department of the Commonwealth of Pennsylvania and was designated as State Highway Route No. 422.

2. That a piece or parcel of said public road beginning at the north side of the private road leading to the property of Vincent Barelleto and extending in a north and northwesterly direction to the Jordan Township line, as shown on the blue print hereto attached, has become useless, inconvenient and burdensome to the Township of Chest.

3. Your petitioners, therefore, pray the Court that the said piece or parcel of said Highway Route No. 422 may be vacated, agreeably to the acts of General Assembly in such cases made and provided, And they will ever pray.






