TO THE HONORABLE THE JUDGE OF THE ABOVE NAMED COURT:

The petition of the SUPERVISORS OF DECATUR TOWNSHIP, Clearfield County, Pennsylvania, under the provisions of the Act of July 10th, 1947, P. L. 1481, Section 16 (53 P.S. 19093-1115), respectfully represents:

1. Your petitioners respectfully pray your honorable Court for an order to relocate the intersection of a Township road with State Highway Route 1749, which now intersects said Route 1749 at a point 705 feet Northerly of the intersection of Route 1750 with Route 1749, in Decatur Township, said change as shown on sketch hereto attached and made a part hereof.

2. The petition is to straighten the Southern intersection of said Township Highway for a distance of 300 feet, so that it shall intersect Route 1749 a distance of 240 feet Southerly from the present intersection, and being 460 feet northerly from intersection of Route 1749 with Route 1750, said new road to be 25 feet in width.

3. And that there be vacated the old approach to said State Highway Route 1749, which was a width of 21 feet.

4. The proposed change is to straighten the said township road, shorten it to a distance of 300 feet, as shown on

sketch in dotted lines, to intersection of Route 17~~E~~50, 240 feet Southerly from the present intersection, thus giving a straighter approach and a better intersection on Route 17~~E~~50.

5. The cost of said change and alteration will not exceed the sum of Fifty Dollars (\$50.00), release of damages as hereto attached and made a part hereof, and the work of changing and relocating the said highway is to be performed by Kenneth L. Hall, who proposes to furnish your petitioners good and sufficient bond that the said relocation and new road shall be equal to the existing road.

WHEREFORE, your petitioners respectfully pray your honorable Court to make an order authorizing the relocation of the said Township road, as herein prayed for, and declare the same as a public road, and the previous location be vacated as prayed for.



O R D E R

NOW, July 29, 1948, Petition of Supervisors of Decatur Township presented, and it appearing to the Court that the relocation and vacation of a portion of Township Road in Decatur Township shall not exceed 300 feet and will cost less than One Thousand Dollars, sketch and release having been attached to said petition, and that the said relocation is advantageous, it is therefore, ORDERED, ADJUDGED AND DECREED, That the Supervisors of Decatur Township be and are hereby authorized to move the intersection of said township highway with Route 1749, Southerly a distance of 240 feet, and at a point 460 feet northerly from intersection of Route 1750 leading from Sanbourn to West Decatur, and with Route 1749 leading from Coal Run to West Decatur, said new road to be 25 feet in width, and to abandon approximately 300 feet of former township road 21 feet in width and intersecting with Route 1749 at a point 705 feet Northerly from intersection of State Highway Route 1750 and 1749. The work of the said relocation and vacation to be accomplished by Kenneth L. Hall, as set forth in said petition, Supervisors to determine sufficiency of bond.
