Roads in Moose Creek Plot of Lots.

IN RE:: ACCEPTANCE OF ROADS : No. September Sessions, 1948
IN LAWRENCE TOWNSHIP :

To the Honorable F. Cortez Bell, President Judge of Said Court:

The Petition of the Road Supervisors of Lawrence Township,
Clearfield County, Pennsylvania respectfully represents:

1. That your Petitioners desire to accept and adopt as township highways and streets the following streets which were dedicated as such by Harold J. Boulton on the Plot of Moose Creek Lots in Lawrence Township, Clearfield County, Pennsylvania, recorded in Clearfield County on September 29, 1938, in Miscellaneous Book 50 at page 565:

ONE----Maple Avenue Extension--200 feet North from
Center Street - 50 feet wide.

TWO----Poplar Avenue--North from Route 17, 117, 600
feet - 50 feet wide.

THREE--Moose Street Extension--East 312 feet -
50 feet wide.

FOUR---Center Street--400 feet from Poplar Avenue
to Guinea Hill Road - 50 feet wide.

2. Also the following highways and streets located in the Richard Shaw Addition to Clearfield Borough as dedicated by Richard Shaw on November 8, 1881, said Plot being recorded in Clearfield County in Deed Book 20 at page 222:

ONE----West Second Avenue--extending from the end
of the present Township Road Southward 500
feet to the Susquehanna River - 60 feet wide.

3. Also the following highways and streets dedicated as such by Peale, Peacock, and Kerr, Inc., recorded in Clearfield County on July 18, 1946 in Deed Book 377 at page 244:

ONE----First Avenue--from Highway Route 1738, 400
feet to Spruce Street; thence along Spruce
Street 375 feet to Township Road - 33 feet
wide.

TWO----Second Avenue--from Highway Route 1738, 500
feet South - 33 feet wide.

4. Also the following highways and streets located in Highview Village, shown in the Plan of Lots recorded in Clearfield

County on March 10, 1948, in Miscellaneous Book 69 at page 565:

ONE----Legion Road--From Route 17098, North 811
feet - 60 feet wide.

TWO----Highview Road--From Route 17098, North
832 feet - 60 feet wide.

5. That your Petitioners at a special meeting on
August , 1948, adopted and approved a Resolution accepting the
above-mentioned highways and streets as township highways and
streets. A copy of said Resolution is hereto attached and made a
part of this Petition.

6. That said adoption and acceptance of said streets is
in accordance with the Act of Assembly of May 1, 1933, P. L. 103
as amended by the Act of July 18, 1935, P. L. 1308.

Wherefore your Petitioners respectfully pray that your
Honorable Court will approve the adoption and acceptance of said
described streets in the Plots of Harold J. Boulton (Moose Creek
Lots); Richard Shaw Addition; Peale, Peacock and Kerr, Inc., Plan
of Lots, and the Highview Village Plan of Lots as Township Highways
and Streets.

AND NOW, August ~~28~~²⁵, 1948, upon consideration of the foregoing Petition and attached Resolution, the adoption and acceptance of the aforementioned streets in the Plots of Harold J. Boulton (Moose Creek Lots); Richard Shaw Addition; Peale, Peacock and Kerr, Inc., Plan of Lots, and the Highview Village Plan of Lots as Township Highways and Streets is hereby approved.

RESOLUTION

BE IT HEREBY RESOLVED, that the Road Supervisors of Lawrence Township accept and adopt as Township Highways and Streets the following Streets which have been dedicated as public highways in the said Township:

1. The following streets which were dedicated as such by Harold J. Boulton on the Plot of Moose Creek Lots in Lawrence Township, Clearfield County, Pennsylvania, recorded in Clearfield County on September 29, 1938, in Miscellaneous Book 50 at page 565:

- a. Maple Avenue Extension--200 feet North from Center Street - 50 feet wide.
- b. Poplar Avenue--North from Route 17, 117, 600 feet - 50 feet wide.
- c. Moose Street Extension--East 312 feet - 50 feet wide.
- d. Center Street--400 feet from Poplar Avenue to Guinea Hill Road - 50 feet wide.

2. The following street located in the Richard Shaw Addition to Clearfield Borough as dedicated by Richard Shaw on November 8, 1881, said Plot being recorded in Clearfield County in Deed Book 20 at page 222:

- a. West Second Avenue--extending from the end of the present Township Road Southward 500 feet to the Susquehanna River - 60 feet wide.

3. The Following highways and streets dedicated as such by Peale, Peacock, and Kerr, Inc., recorded in Clearfield County on July 18, 1946 in Deed Book 377 at page 244:

- a. First Avenue--from Highway Route 1738, 400 feet to Spruce Street; thence along Spruce Street 375 feet to Township Road - 33 feet wide.
- b. Second Avenue--from Highway Route 1738, 500 feet South - 33 feet wide.

4. The following highways and streets located in Highview Village, shown in the Plan of Lots recorded in Clearfield County on March 10, 1948, in Miscellaneous Book 69 at page 565:

- a. Legion Road--from Route 17098, North 811 feet - 60 feet wide.
- b. Highview Road--from Route 17098, North 832 feet - 60 feet wide.

Said streets are to be maintained as Township Highways
by the Road Supervisors of Lawrence Township.

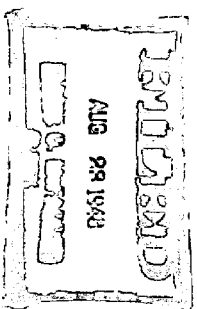
