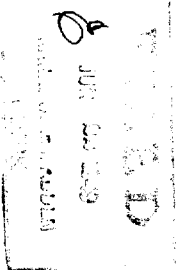


2. That attached hereto are copies of notices served on the property owners affected by the said abandonment together with their acceptance of said notices.

AN ORDINANCE TO VACATE A ROAD OR SECTION OF ROAD WITHIN THE TOWNSHIP OF BLOOM, CLEARFIELD COUNTY, PENNSYLVANIA.

WHEREAS, in the judgment of the Supervisors of Bloom Township, Clearfield County, Pennsylvania, it is in the interest of public convenience and economy to vacate, by Ordinance, a section of road herein described, now therefore:

BE IT ORDAINED AND ENACTED by the Supervisors of Bloom Township, Clearfield County, Pennsylvania, and it is hereby ordained and enacted by authority of the same.

Section 1. That in the judgment of the Supervisors, the following described road be and the same is hereby vacated:

All that certain section of earth road having a width of 18 feet and being a former portion of State Highway Route 861-4 within the boundaries of Bloom Township, Clearfield County, Pennsylvania, and beginning at a point on said State Highway Route 1430 feet South East of Township Route 484 and approximately 8 miles from the Borough of Sykesville; thence along its several courses in a generally South Eastern direction 727 feet to a point on said State Highway Route 861-4 said point being a distance of approximately 5 miles from the Borough of Curwensville.

Section 4. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

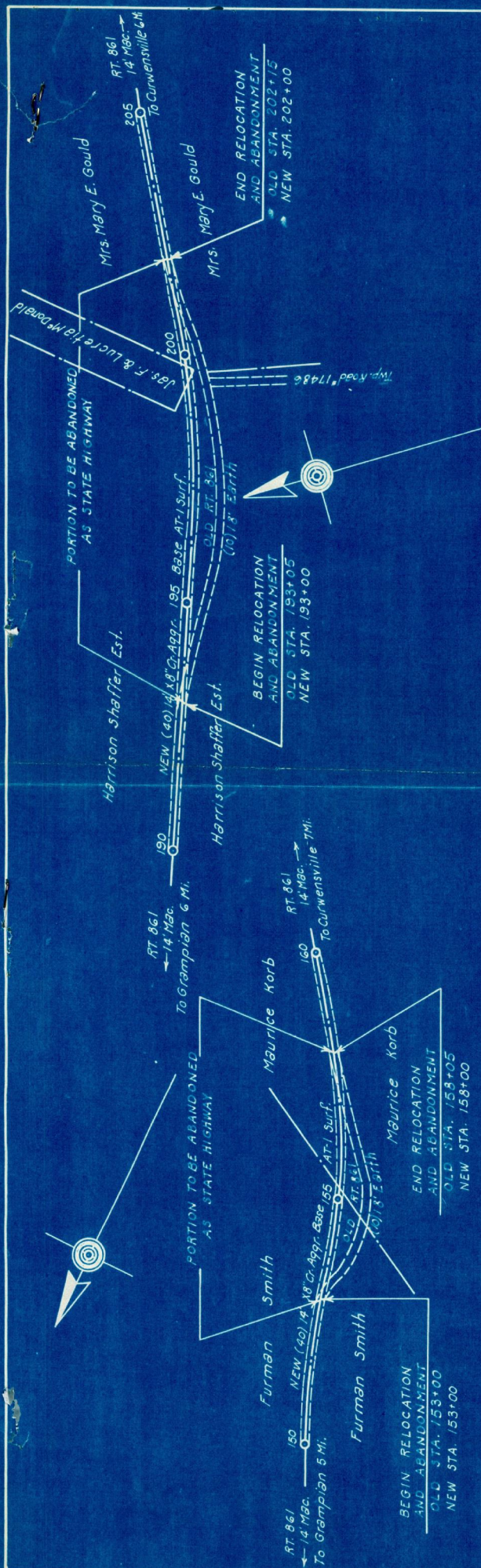
