P E T I T I O N

TO THE HONORABLE F. CORTEZ BELL, PRESIDENT JUDGE OF SAID COURT:

The petition of John H. Matthews of Penn Township, Clearfield County, Pennsylvania, respectfully represents:

1. That your petitioner labors under inconvenience for want of a private road to lead from the lands of the Penn Township Coal Company in Penn Township, on whose lands your petitioner has a coal operation under lease with said Company, to State Highway Route No. 17028, leading from the Borough of Grampian, Pennsylvania, through Walltown, Penn Township, to Chestnut Grove at a point on said Highway near the residence now or formerly of Thomas McCartney in said Township of Penn.

2. That the proposed private road is intended to replace a public road heretofore vacated in Penn Township by proceedings filed in the above Court to No. 13, September Sessions 1927, which said former public road (now vacated) had its beginning at a cross road near the residence now or formerly of Thomas McCartney in said Township of Penn; thence extended in a Northerly direction up Bell Run over lands of Vincent Flynn, E. J. Flynn and Mrs. T. L. Rafferty, and the Penn Township Coal Company to a point where said Township road crossed Bell Run at the line dividing Penn from Bell Township, Clearfield County, Pennsylvania, having an over all length of approximately one (1) mile.

3. That your petitioner has under lease with the Penn Township Coal Company more than two thousand (2,000) Acres of coal land in Penn Township, not accessible to any road or highway and in order to transport said coal to the main highway it is necessary to pass over or across the intervening lands of others.

WHEREFORE your petitioner respectfully prays your Honorable Court to appoint proper persons to view and lay out a private road from the Penn Township Coal lands in Penn Township to the main highway in said Township, in accordance with the Act of Assembly of May 17, 1901; P. L. 259, in such case made and provided.

And your petitioner will ever pray.


