

REPORT AND SURVEY

The Board of Supervisors of the Township of Lawrence, Clearfield County, Pennsylvania, files this Report and Survey in the Office of the Clerk of the Court of Quarter Sessions of Clearfield County, Pennsylvania, pursuant to Act of Assembly of July 10, 1947, P. L. 1481, Sections 1101 and 1102:

1. That on November 15, 1949, notice was given to all interested parties of the intention on the part of the Board of Road Supervisors of Lawrence Township, Clearfield County, Pennsylvania, to accept a certain road from Pennsylvania State Highway Route #17084 to Pennsylvania State Highway Route #17041 as a Township Road by an Ordinance.

2. That the owners of the properties adjacent to this Road are Mrs. Blair Sykes, Harold J. Boulton and W. A. E. Leitzinger, all who have executed Deeds and Quitclaims for the Right-of-Way on said Road.

3. That on December 3, 1949, at Clearfield, Clearfield County, Pennsylvania, pursuant to said Notice, a hearing was held by the Board of Supervisors, and the Board received the Deeds and Quitclaims for the Right-of-Way on said Road. It was unanimously decided by the Board of Supervisors that the Road as shown on the attached Survey should be adopted as a Township Road Thirty-three (33') feet in width.
