PETITION FOR APPROVAL

To The Honorable F. Cortez Bell, P. J.

The Pike Township supervisors, Paul Shively, Howard Bloom and Clair Whitaker, file this Petition for Approval of vacating and supplying a new road in Pike Township and they represent:

FIRST: That the petitioners ask Your Honorable Courts approval for vacating a road beginning at a point at the intersection of a proposed road with the road to be vacated; thence South forty eight (48°) degrees forty one (41) minutes East, one hundred twenty-three and one-tenth (123.1) feet to a point in the center of the highway; thence South twenty-six (26°) degrees thirty seven (37) minutes East, two hundred eighty one and nine-tenths (281.9) feet to a point in the center of the highway; thence South fifty-nine (59°) degrees four (4) minutes East, one hundred forty-eight and seven-tenths (148.7) feet to a point in the center of the highway; thence South eighty (80°) degrees fifty-nine (59) minutes East, one hundred sixty-one (161) feet to point in the center of the highway; thence North eighty (80°) degrees twenty-four (24) minutes East, two hundred ninety-five and five-tenths (295.5) feet to center of the highway; thence North eighty-five

(85°) degrees eight (8) minutes East, two hundred eighty-eight and two-tenths (288.2) feet to a point where said road intersects with the highway leading between Curwensville and Grampian. A map is hereto attached and incorporated in this Petition which fully describes the road to be vacated.

SECOND: The aforesaid road that is vacated is to be supplied and a new road is to be opened and constructed as follows:

Beginning at a point in the center of the highway South forty-seven (47°) degrees fifty-six (56) minutes East, sixty-five and six-tenths (65.6) feet from the Bell and Hauck corner and being the same starting point for the description of the road in paragraph (1). Beginning at this point, thence South twenty-eight (28°) degrees fifty-five (55) minutes East one hundred eighty-one and seven-tenths (181.7) feet to a point in the center of the road; thence South two (2°) degrees nine (9) minutes East one hundred fifty-three and five-tenths (153.5) feet to point in the center or the road; thence South twenty (20°) degrees fifty-four (54) minutes East, two hundred fifty-eight and seven-tenths (258.7) feet to a point in the center or the road; thence South fifty (50°) degrees twenty-three (23) minutes West, eighty-one and seven-tenths (81.7) feet to a point in the center or the road; thence South seventy-eight (78°) degrees twenty-four (24) minutes, East, eighty-nine and two-tenths (89.2) feet to a point in the center or the road; thence North eighty-six (86°) degrees fifty-two (52) minutes East, one hundred seventy-eight and two-tenths (178.2) feet to a point in the center or the road; thence North sixty-seven (67°) degrees thirty-seven (37) minutes East, two hundred twenty-two and nine-tenths (222.9) feet to a point in the

center of the road; thence North fifty-nine (59°) degrees no (00) minutes East, eighty-four and four-tenths (84.4) feet to post in road, thence North sixty-six (66°) degrees forty-seven (47) minutes East, three hundred seventeen and one-tenth (317.1) feet to the terminal of the road which is being vacated in paragraph (1). A copy of said map is attached hereto and incorporated herein and made a part of this Petition and describes the road to be opened and constructed.

THIRD: That the cost of said vacating and re-opening and location of the road shall not exceed One Thousand (\$1000.00) Dollars and that the same will approximately cost  
*Three Hundred (\$300.00) Dollars.*

FOURTH: That the only persons along said highway are Grace M. Bell and Louis Hauck, and attached hereto are releases relinquishing all rights to damages for the re-location of the road.

FIFTH: That the Township supervisors have unanimously agreed to the vacating of the road described in paragraph (1), and re-locating and constructing a road as described in paragraph (2) and both roads being more fully described in the map hereto attached and they pray the court to approve this petition in pursuance to the Act of Assembly in 53 Purdon Statutes Section 19093 - 1115, Supplements.

SIXTH: That the undersigned are all the supervisors of Pike Township and the aforesaid roads described in paragraph (1) and paragraph (2) are located in Pike Township, Clearfield County, Pennsylvania.

ORDER OF COURT


NOW, this 8 day of November, 1951, the Court, after reading and considering the within Petition, will make the following order.

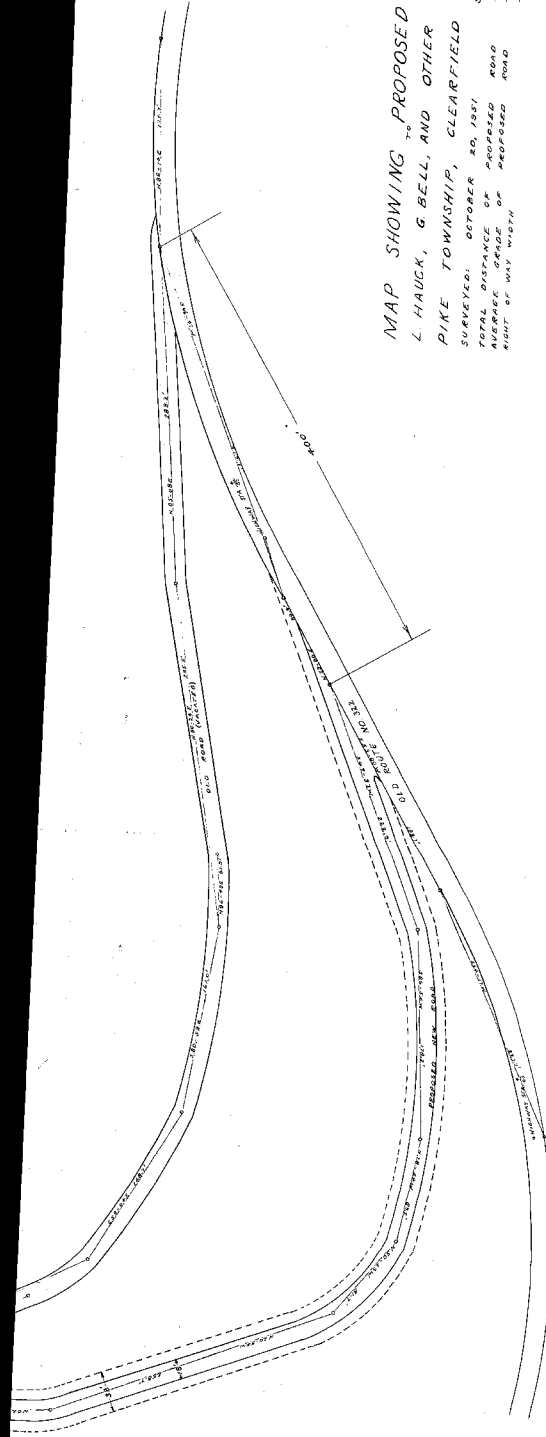
