#### PETITION

The petition of Joseph W. Young, Joseph B. Thompson and George Carns respectfully represents:

(1). They are the duly elected Supervisors of Lawrence Township, Clearfield County, Pennsylvania.

(2). Plans of Indian Road and Arrowhead Way have been duly adopted, approved and recorded by your petitioners, having been dedicated to public use by A. L. Moore, Lillie L. Moore and A. L. Moore, Jr., by written declaration dated May 20, 1953.

(3). Said roads are located wholly within Lawrence Township and are each forty (40) feet in width and are further described as follows:

INDIAN ROAD: Beginning at a stake at the west side of the fifty foot legal right of way of State Rt. 17099, said stake being located 440 feet south-west of the intersection of Rt. 17099 and Coal Hill Road, Rt. 17040, and at the center of Indian Road, thence by the center line of Indian Road North 79 degrees 54 minutes West 471.09 feet to a stake, thence by a line curving to the right with a radius of 2865 feet, 610.0 feet to a stake, thence North 67 degrees 42 minutes West 51.5 feet to a road leading North 318 feet to the Coal Hill Road, the herein described Indian Road having a total length of 1132.6 feet.

ARROWHEAD WAY: Beginning at a stake at the center line of "Indian Road", said stake being located 215 feet west of the intersection of Indian Road and State Rt. 17099 and at the center of Arrowhead Way, thence South 49 degrees 17 minutes West 274.1 feet to a stake, thence by a line curving to the right with a radius of 150.1 feet, 113.6 feet to a stake, thence by a line curving to the right with a radius of 2292 feet, a distance of 497.0 feet to a stake, thence North 74 degrees 40 minutes West 129.3 feet to the west side of a road leading North 665 feet to Coal Hill Road. The above described Arrowhead Way having a total length of 1014 feet.

(4). The acceptance of said roads would be a benefit to Lawrence Township.

(5). Attached hereto and made a part hereof is a certified and attested copy of a resolution duly passed by the Board of Supervisors of Lawrence Township accepting said roads.

WHEREFORE, your petitioners request that your Honorable Court consent to the acceptance of Indian Road and Arrowhead Way by endorsing your consent thereto.


I hereby certify that the following is a true and correct copy of a resolution duly adopted by the Board of Supervisors of Lawrence Township, Clearfield County, Pennsylvania, at a regular meeting of said Board held on November 5, 1953:

BE IT RESOLVED: That the roads hereinafter designated, each forty (40) feet in width and each constructed to the requirements of this Board, be and hereby are accepted as Township Roads subject to the consent of the Court of Quarter Sessions of Clearfield County, Pennsylvania, to be endorsed hereon:

(1). INDIAN ROAD: Beginning at a stake at the west side of the fifty foot legal right of way of State Rt. 17099, said stake being located 440 feet south-west of the intersection of Rt. 17099 and Coal Hill Road, Rt. 17040, and at the center of Indian Road, thence by the center line of Indian Road North 79 degrees 54 minutes West 471.09 feet to a stake, thence by a line curving to the right with a radius of 2865 feet, 610.0 feet to a stake, thence North 67 degrees 42 minutes West 51.5 feet to a road leading North 318 feet to the Coal Hill Road, the herein described Indian Road having a total length of 1132.6 feet.

(2). ARROWHEAD WAY: Beginning at a stake at the center line of "Indian Road", said stake being located 215 feet west of the intersection of Indian Road and State Rt. 17099 and at the center of Arrowhead Way, thence South 49 degrees 17 minutes West 274.1 feet to a stake, thence by a line curving to the right with a radius of 150.1 feet, 113.6 feet to a stake, thence by a line curving to the right with a radius of 2292 feet, a distance of 497.0 feet to a stake, thence North 74 degrees 40 minutes West 129.3 feet to the west side of a road leading North 665 feet to Coal Hill Road. The above described Arrowhead Way having a total length of 1014 feet.

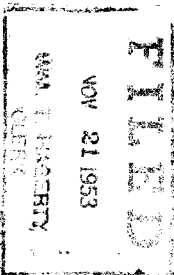
