RESOLUTION NO. 12

BE IT RESOLVED, and it is hereby resolved by the Board of Supervisors of the Township of Sandy, in regular session assembled, as follows:

WHEREAS, by virtue of a Petition filed the 7th day of September, 1948, in the Court of Quarter Sessions of Clearfield County, to No. 1, December term, 1948, the Honorable Court was requested to appoint viewers for the purpose of opening portions of McLane Avenue and Euclid Avenue in the Township of Sandy, Clearfield County, Pennsylvania, and,

WHEREAS, on the 11th day of October, 1948, a jury of view was held at which time testimony was taken and the viewers found the said road necessary, and returned the same for public use, and,

WHEREAS, on the 13th day of December, 1948, said return was confirmed nisi si, and on the 7th day of March, 1949, the said viewers report was confirmed absolutely,

NOW, THEREFORE, BE IT RESOLVED, and it is hereby resolved that the following roads be, and the same are hereby adopted as part of the highway system of the Township of Sandy, County of Clearfield and State of Pennsylvania, as follows:

McLane Avenue commencing at Fourth Street and running in a Northwesterly direction six hundred and sixteen (616) feet to Fifth Street; McLane Avenue commencing at Fourth Street and running in a Southeasterly direction five hundred and sixty-six (566) feet to Third Street.

Euclid Avenue commencing at Fourth Street and running in a Northwesterly direction six hundred and sixteen (616) feet to a point; Euclid Avenue commencing at Fourth Street and running in a Southeasterly direction three hundred (300) feet to an alley.

That the proposed roads known as McLane Avenue and Euclid Avenue are laid out over dedicated streets

under the maps of the DuBois Land and Improvement Company, the original map of which is recorded among the records of Clearfield County in the Recorder's Office in Deed Book 66, Page 607.

Adopted by unanimous vote this 1<sup>st</sup> day of February,  
1954.


