PETITION

To the Honorable John J. Pentz, President Judge of said Court:

The petition of Raymond Barto, Herman Lefebvre and  
John Kandrach respectfully represents:

1. That they are the duly elected Supervisors of  
Gulich Township, Clearfield County, Pennsylvania, a township  
of the second class.
2. That the original plan of the Village of Janes-  
ville as laid out in town-lots, abutting on streets and alleys  
dedicated to public use by the original owners, has since  
been extended and the streets and alleys projected as shown  
on the plan thereof, - a sketch thereof being hereto attached  
and made a part hereof, as the proposed plan.
3. That the lately developed section of said village  
of Janesville has become populated as a residential community  
and the residents thereof have petitioned the Board of Super-  
visors to accept as part of the public road system of Gulich  
Township, the following described and projected streets and  
alley, to wit:

(A) Simpson Street for a uniform width and breadth  
of 60 feet, thirty feet on each side of the  
centre line thereof for a length of 230 feet,  
more or less, from the southern intersection of  
Simpson Street and Oak Street, bearing North 31°  
21' East to its intersection with Gulich Alley;  
thence from the Northern intersection of said  
Simpson Street and Gulich Alley for a uniform  
width and breadth of 33 feet (16½ feet on each  
side of the centre line thereof) bearing North

58° 39' West 120 feet to its intersection with a 40 foot unnamed Street; thence thereby for a uniform width and breadth of forty feet, (20 feet on either side of the centre line thereof), North 31° 21' East 465 feet to its intersection with State Highway Route 253-453, being Highway Route leading from Ramey to Allemansville.

(B) Chestnut Street for a uniform width and breadth of 60 feet, 30 feet on either side of the centre line thereof), for a length of 230 feet, between the Northern intersection of Chestnut Street and Gulich Alley and the Southern intersection of Chestnut Street and Oak Street, and bearing North 31° 21' East.

(C) Gulich Alley for a uniform width and breadth of 33 feet (16½ feet on either side of the centre line of said Alley: thence running North 58° 39' West 610 feet, more or less, from the Eastern intersection of Gulich Alley and Simpson Street to the Western intersection of said Gulich Alley and the Ramey Highway (Township) (Road) which extends through the Northwesterly corner of the property of Ezzie Bardi.

4. That all of the said public road is located wholly within Gulich Township.

5. That the acceptance of said road would be of benefit to Gulich Township and necessary for the accomodation of the traveling public; that the proposed public road is within the confines of dedicated streets and alleys, and have long since been opened for public use; and that the benefits accruing to the abutting property owners exceed any disadvantages to the users thereof.

6. Attached hereto and made a part hereof is a certified copy of a resolution adopted by the Board of Supervisors of Gulich Township, accepting 33 feet in width, 16½ feet on either side of the centre lines of said streets and alley as part of the public road system of Gulich Township.

WHEREFORE, your petitioners request that your Honorable Court consent to the acceptance of rights of way, 33 feet in width, on Simpson Street, extending North 31° 21'



East, 230 feet from its intersection with Oak Street to Gulich Alley; on Chestnut Street, extending North 31° 21' East, 230 feet to its intersection with Gulich Alley; on Gulich Alley, extending North 58° 39' West, 610 feet from its intersection with Simpson Street to its intersection with Chestnut Street; and on Unnamed Street, extending North 31° 21' East, 465 feet to its intersection with State Highway Route 253-453 leading from Ramey to Allemansville, as shown on the attached plan thereof, marked with red lines, by endorsing your consent thereto, as provided by the Second Class Township Code (53P.S. Sec. 1147).

I HEREBY CERTIFY that the following is a true and correct copy of a resolution duly adopted by the Board of Supervisors of Gulich Township, Clearfield County, Pennsylvania, at a regular meeting of said Board held September 7t, 1954:


WHEREAS, the residents and property owners of the lately populated section of Janesville have petitioned the Board of Supervisors to accept as part of the public road system of Gulich Township, the hereinafter projected and dedicated Alley and Streets; and,

WHEREAS, the following described Alley and Streets are projected highways in said Village of Janesville, as laid out by the original owners of the land upon which Janesville has been built: Now therefore

BE IT RESOLVED that Gulich Alley, extending North 58° 39' West, 610 feet from its intersection with Simpson Street to its intersection with Chestnut Street; Simpsom Street, extending North 31° 21' East, 230 feet from its intersection with Oak Street to its intersection with Gulich Alley; Chestnut Street, extending North 31° 21' East, 230 feet from its intersection with Oak Street to its intersection with Gulich Alley; and an Unnamed Street, extending North 31° 21' East, 465 feet from its intersection with Gulich Alley to its intersection with State Highway Route 253-453 leading from Ramey to Allemansville; thirty-three (33) feet in width within the lines of said streets and alley, and constructed to the requirements of this Board, be and the same is accepted as a Township Road: subject to the consent of the Court of Quarter Sessions of Clearfield County, Pennsylvania, to be endorsed thereon.

North 31° 21' East, 465 feet from its intersection with

in width within the lines of said Alley and Streets, as a  
township road in the Township of Gulich; and that said alkey
