PETITION

To the Honorable John J. Pentz, President Judge of said Court:

The petition of John Kandrach, Raymond Barto and Herman Lefebvre respectfully represents:

1. That your petitioners are the Supervisors of the Township of Gulich, a second class township of the County of Clearfield.

2. That the State Highway Department of the Commonwealth of Pennsylvania in improving and locating Route 276, Section 4, of the State Highway System in the Township of Gulich, Clearfield County, under the authority of the Act of Assembly in such case made and provided, did abandon and thus turn over to the Road District of the Township of Gulich, from Station 84 # 00 to a point at Station # 28, a distance of approximately .1000 of a mile.

3. That the said portion of the State Highway abandoned are of no use or value to the travelling public, or the abutting property owners, and for the Road District of the Township of Gulich to maintain, would be useless and burdensome.

4. That the aforesaid piece of Highway abandoned by the State Highway Department is situate along State Highway Route 276, Section 4, leading from Ramey to Glasgow, via the White Rock, a distance of approximately 528 feet in length; a blue print or sketch of which is hereto attached and made a part hereof.

WHEREFORE YOUR PETITIONERS RESPECTFULLY pray your Honorable Court to appoint Viewers for the purpose of viewing and vacating the portion of the original State Highway Route 276, section 4, herein specifically set forth and described, which due to the abandonment thereof as a part of the State Highway system, have reverted to the Road District of the Township of Gulich, for upkeep and maintenance.



CLEARFIELD COUNTY, SS.:

At a Court of Quarter Sessions of the Peace of the County of Clearfield, Pa., held at Clearfield, Pa., in and for said County, on the 21st day of February in the year of our Lord, one thousand nine hundred and fifty five.

By the Honorable Singleton Bell, President Judge of the said Court: Upon the petition of sundry inhabitants of the Township of Gulich, in the County aforesaid setting forth that .....  
the aforesaid piece of Highway abandoned by the State Hwy. Department is situate along State Hwy. Route 276, Section 4, leading from Ramey to Glasgow, via the White Rock a distance of approximately 528 feet in length; a blue print or sketch of which is hereto attached and made a part hereof. Approximately .1000 of a mile.

and, therefore, praying the Court to appoint proper persons to view and vacate said road between the points mentioned, whereupon the said Court, upon due consideration had of the premises, do order and appoint from and among the County Board of Viewers A. B. Shaw, Ben Hughes and

Guy Heil. who have been duly appointed by the said Court on the

County Board of Viewers, and filed their oaths of office in the office of the Court of Common Pleas of the County aforesaid, as required by law and are, therefore, duly qualified to perform the duties of their appointment, with impartiality and according to the best of their judgment; are to view the said road, and after having viewed the same, if they, or a majority of them, do agree that there is no necessity for said road, they shall proceed to vacate the same as agreeably to the desire of the petitioners as may be, and make report thereof to the next Court of Quarter Sessions to be held in and for said County, stating particularly whether there is any necessity for said road, or whether the same should be vacated; and the reason why, together with a plot, or draft, thereof showing the courses and distances with reference to the improvements through which said road passes.

And in case the viewers aforesaid shall decide in favor of vacating said road, they shall obtain from the persons through whose lands the said road passes, or otherwise affected, or damaged, by the vacating of said road, releases from whatever damage they may sustain by the vacation of said road; and in case the owners of such lands, or persons affected, thereby refuse to release their claim to damages, the said Viewers shall assess the same, taking into consideration the advantages, as well as the disadvantages, arising from the vacation of said road; and make report of such assessment; which report they shall in like manner transmit to the next Court of Quarter Sessions, with the draft, or plot, aforesaid. In which said reports they shall state that they have been sworn, or affirmed, according to law, and that due and legal notice was given of the time when and the place where they would meet, to view said road and the time and place of hearing.

RETURN OF VIEWERS.

TO THE HONORABLE THE JUDGE OF QUARTER SESSIONS OF THE PEACE, IN AND FOR THE COUNTY OF CLEARFIELD, PA.

We, the undersigned Viewers, duly appointed by your Honorable Court by the foregoing order, from and among the County Board of Viewers who have been duly appointed by your Honorable Court and have filed their oaths of office in the Court of Common Pleas of Clearfield County, beg leave to report as follows:

That notice of the time of the view and of the hearing day was duly served according to law upon the Commissioners of Clearfield County, and the Board of Supervisors

of the Township of Gulich , and that three notices thereof were posted along the route of the said road to be vacated, that the said view would be held on the

20th day of April , A. D. 1955 and that the public hearing, as required by the Act of Assembly, and the Rules of Court, would be held in the Arbitration Room in the Court House, in Clearfield.

Pa., on the 22nd day of April A. D., 1955, at 10:30 o'clock A.M., and that said Viewers, appointed by the said order, viewed the road desired to be vacated, and that there were present at the view John Kandrach, one of the Supervisors of Gulich Township

parties interested, either in favor of or against vacating said road. And that the aforesaid hearing was held in the Arbitration Room in the Court House, in Clearfield, Pa., on the 22nd day of April ,

And that after the view and hearing above mentioned, the undersigned Viewers do agree that said road has become useless, inconvenient and burdensome and of no use to the traveling public and your undersigned Viewers recommend the vacation for public use a part of Legislative Route 276, in Gulich Township, leading from Ramey to Glasgow, which became abandoned as a part of the State Highway System by reason of the construction and relocation of said highway and as a result of said construction and relocation reverted back to the Township of Gulich and presently forms a part of its general road system. The section of public road in the Township of Gulich that is here recommended for vacation is specifically described as follows:

Beginning at point of intersection of abandoned portion of State Highway Route 276, leading from Ramey to Glasgow with new State Highway Route 276, as relocated at Station 84 ± 00; thence extending in a northerly direction over old State Highway Route 276, a distance of five hundred and twenty-eight (528) feet to Station 89 ± 28, where said abandoned portion of old Legislative Route 276 intersects with State Highway Route 857, leading from Tyrone to Ramey, Pennsylvania.

**ORDER TO VACATE**

NOTE.—In case of a private road, the release must be executed in favor of the petitioner for said road.

Also, viewers will carefully note the number of days employed and set the amount out at the foot of their return.

Reviewers cannot interfere with the damages assessed by the original viewers, except so far as the location may be changed by the reviewers.

N. B.—If the viewers believe the parties are not entitled to damages, taking into consideration the advantages as well as the disadvantages of the road, they will report to that effect.


