REPORT OF THE BOARD OF SUPERVISORS OF KARTHAUS

TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA

TO THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE OF SAID COURT:

✓ The board of Supervisors of Karthaus Township,  
Clearfield County, Pennsylvania respectfully report as follows:  
1. That the undersigned were duly elected and  
qualified as Supervisors of the Township of Karthaus, Clearfield  
County, Pennsylvania.

2. That the Supervisors as aforesaid, pursuant to the  
provisions of the Act of 1933 P.L. 511 Sec. 1102 (a), 53 P.S.  
19093 - 1102 (a), gave ten days written notice by registered  
mail to Green Glenn Corporation, DuBois, R.D.#2, Pennsylvania,  
and to Karthaus Estate, Harold J. Boulton and H. F. Van Valza  
successor trustees c/o Boulton and Boulton, Clearfield,  
Pennsylvania, they being the only known persons in interest, of  
the proposed passage of an ordinance laying out and opening the  
below described road and of the meeting in regard thereto; and  
that further the said Supervisors caused to be posted in conspi-  
cuous places on the proposed road in question, similar notices.

3. That attached to and made a part of this report  
are:

(a) An affidavit of mailing and posting the afore-  
said notices together with the return receipts therefrom, marked  
as exhibit "A".

(b) A copy of the aforesaid notice, marked as exhibit  
"B".

4. That pursuant to the notice as aforesaid, a meeting of the Karthaus Township Supervisors was held at the residence of Robert J. Potter in the Village of Karthaus, Karthaus Township, Clearfield County, Pennsylvania, on the 15th day of June, 1955 at 6:30 o'clock P.M., E.S.T., and that at this meeting the following persons were present:

Homer Stroup, Chairman of the Board of Supervisors,  
Robert J. Potter, Supervisor,  
Mike Kolivaski, Supervisor,  
Irene Potter, Secretary of the Board of Supervisors,  
and that no other person was present.

5. That at the said meeting no objection was made to the proposed laying out and opening of the said road.

6. That the road proposed to be laid out and opened is described as follows:

Being thirty-three feet in width and Beginning in Karthaus Township, Clearfield County, Pennsylvania at the point of intersection of said road with the Road leading from Karthaus Village to Dutch Hollow near the Mosquito Creek Bridge on lands of the Karthaus Estate; thence South 35 degrees West 345 feet to a post; thence South 48 degrees West 200 feet to a post; thence South 30 degrees West 200 feet to a post; thence South 24 degrees West 400 feet to a post; thence South 52 degrees West 200 feet to a post; thence South 74 degrees West 100 feet to a post; thence South 82 degrees West 200 feet to a post; thence South 69 degrees West 200 feet to a post; thence South 57 degrees West 200 feet to a post; thence South 66 degrees 30 minutes West 400 feet to a post; thence South 74 degrees West 400 feet to a post; thence South 82 degrees West 400 feet to a post; thence South 70 degrees West 200 feet to a post; thence South 62 degrees West 400 feet to a post; thence South 50 degrees West 200 feet to a post; thence South 41 degrees 30 minutes West 500 feet to a post; thence South 77 degrees West 300 feet to a post; thence South 34 degrees 30 minutes West 700 feet to a post, thence South 38 degrees West 400 feet to a post; thence South 41 degrees West 700 feet to a post; thence South 35 degrees West 200 feet to a post; thence South 23 degrees West 300 feet to a post; thence South 34 degrees West 400 feet to a post; thence South 18 degrees 30 minutes West 300 feet and ending at the Covington Township Line on the road leading to Keewaydin.

7. That attached hereto, made a part hereof and marked exhibit "C" is a copy of the proposed ordinance to lay out and open the above described Township Road.

8. That attached hereto, made a part hereof and marked exhibit "D" is a draft or survey of the road in question whereon the width of the road is fixed at thirty-three feet.

9. That there are no improvements along the line of the said road.

10. That the above described proposed Township Road, prior to the year 1929 was a Township Road, however in that year the same was vacated by the Court, copies of the proceedings in that matter being hereunto attached and marked exhibit "E".

11. That in the opinion of the undersigned Supervisors the laying out and opening of the before described road is necessary to the public convenience.

12. WHEREFORE, the undersigned Board of Road Supervisors of Karthaus Township, Clearfield County, Pennsylvania respectfully request the Court to confirm this report Ni.Si., confirmation absolute to be made by the Clerk of the Court of Quarter Sessions of Clearfield County, Pennsylvania, as of course, unless exceptions thereto are filed within thirty days of the Ni. Si. confirmation as allowed by law.

At a Court of Quarter Sessions of the Peace of the County of Clearfield, Pa., held at Clearfield, Pa., in and for said County, on the 27th day of December in the year of our Lord, one thousand nine hundred and twenty eight.

By the Honorable A. R. Chase, President Judge of said Court: Upon the petition of sundry inhabitants of the Township of Karthaus, in the County aforesaid setting forth that.....

a public road has long since been laid out and opened beginning at a point about 200 feet southeast of the Creek Bridge on the road leading from Karthaus to Dutch Hollow and extending in a southwesterly direction about two miles to the Covington Township line.

That said road has now become useless, inconvenient and burdensome to the township

and, therefore, praying the Court to appoint proper persons to view and vacate said road between the points mentioned, whereupon the said Court, upon due consideration had of the premises, do order and appoint from and among the County Board of Viewers John Scollins,

Esq., Edward Billotte and Jesse E. Dale who have been duly appointed by the said Court on the County Board of Viewers, and filed their oaths of office in the office of the Court of Common Pleas of the County aforesaid, as required by law and are, therefore, duly qualified to perform the duties of their appointment, with impartiality and according to the best of their judgment; are to view the said road, and after having viewed the same, if they, or a majority of them, do agree that there is no necessity for said road, they shall proceed to vacate the same as agreeably to the desire of the petitioners as may be, and make report thereof to the next Court of Quarter Sessions to be held in and for said County, stating particularly whether there is any necessity for said road, or whether the same should be vacated; and the reason why, together with a plot, or draft, thereof showing the courses and distances with reference to the improvements through which said road passes.

And in case the viewers afore said shall decide in favor of vacating said road, they shall obtain from the persons through whose lands the said road passes, or otherwise affected, or damaged, by the vacating of said road, releases from whatever damage they may sustain by the vacation of said road; and in case the owners of such lands, or persons affected, thereby refuse to release their claim to damages, the said Viewers shall assess the same, taking into consideration (the advantages, as well as the disadvantages, arising from the vacation of said road; and make report of such assessment; which report they shall in like manner transmit to the next Court of Quarter Sessions, with the draft, or plot, aforesaid. In which said reports they shall state that they have been sworn, or affirmed, according to law, and that due and legal notice was given of the time when and the place where they would meet, to view said road and the time and place of hearing.
