PETITION

To the Honorable John J. Pentz, President Judge of said Court:

The petition of Carl Weakland, J. J. Kachelries and

Merle L. Myers respectfully represents:

1. That they are the duly elected Supervisors of Beccaria Township, Clearfield County, Pennsylvania, a Township of the second class.

2. That the original plan of the village of Blain City as laid out in town-lots, abutting on streets and alleys dedicated to public use, by Shaw & Dotts, and recorded in the Recorder's Office of Clearfield County, in Misc. Book , page has since been extended and the streets and alleys projected as shown on the plan thereof, - a blue print thereof being hereto attached and made a part hereof.

3. That the lately developed section of said Village of Blain City has become populated as a residential community and the residents thereof have petitioned the Board of Supervisors to accept as a public road the highway intersecting Liberty Street (Township Highway Rt. 804) and thence running North 81° East, twenty feet in width, 420 feet to its intersection with a forty-feet in width, unnamed Street, and thence thereby North 9° West, 460 feet in length to a dead-end.

4. That all of the said public road is located wholly within Beccaria Township.
5. That the acceptance of said road would be of benefit to Beccaria Township and necessary for the accomodation of the traveling public; that the proposed public road is within the confines of dedicated streets and alleys, and have long since been opened for public use; and that the benefits accruing to the abutting property owners exceed any disadvantages to the users hereof.
6. Attached hereto and made a part hereof is a certified copy of a resolution duly adopted by the Board of Supervisors of Beccaria Township, accepting said street and alley as part of the public road system of Beccaria Township.

WHEREFORE, your petitioners request that your Honorable Court consent to the acceptance of the 20 feet wide Alley, running North 81° East, from its intersection with Liberty Street (Township Highway Rt. 804) between the residences of Chester Leyo and Ernest Shore, 420 feet to its intersection with an unnamed Street; and thence thereby North 9° West, 33 feet in width within the lines of said Street, 460 feet to a dead-end, as shown on the attached blue print thereof, colored in red, by endorsing your consent thereto, as provided by the Second Class Township Code (53 P.S. sect. 1147).

WHEREAS, the residents of the lately populated section of Blain City have petitioned the Board of Supervisors to accept as a part of the public road system of Beccaria Township, the hereinafter dedicated and described Alley and Street; and,

WHEREAS, the said Alley and Street are projected highways in said Village of Blain City as laid out by Shaw & Dotts, and recorded in the Recorder's Office, of Clearfield County: Now therefore

BE IT RESOLVED: That the 20 feet wide Alley, running North 81° East, from its intersection with Liberty Street (Township Highway Rt. 804) between the residences of Chester Leyo and Ernest Shore, 420 feet to its intersection with an unnamed Street; and thence thereby North 9° West, 33 feet in width within the lines of said Street, 460 feet to a dead-end, and constructed to the requirements of this Board, be and the same is accepted as a Township Road: subject to the consent of the Court of Quarter Sessions of Clearfield County, Pennsylvania, to be endorsed thereon.
