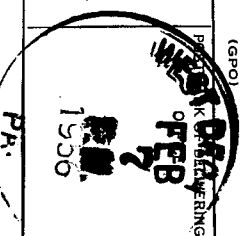

NOTICE OF THE TAKING OVER OF PRIVATE ROAD AS
PART OF THE GENERAL ROAD SYSTEM BY A
RESOLUTION OF THE SUPERVISORS OF
THE TOWNSHIP OF BOGGS

You are hereby notified that the report of the Supervisors of the Road District of the Township of Boggs was filed and confirmed ~~ni.s1.~~ by the Court of Quarter Sessions of Clearfield County, Penna., on February 2, 1956, in conformity with the provisions of the Act of Assembly of July 20, 1953, P.L. 511, Sec. 1102 (a) in such case made and provided, authorizing the taking over as a part of the general road system of the Township of Boggs, a certain private road in Boggs Township:-

Beginning at the intersection of Township Road Route 674 with proposed road, on property of the General Refractories Company in West Decator; thence extending in a southerly direction along the courses and distances of said proposed road which abutts the Tyrone-Clearfield Branch of the Pennsylvania Railroad Co., on the West and the lands of the General Refractories Co, Heddy Goss, David Godisart, John Bordas, George Mease, Raymond Smeal, Leonard Kyler, Walter Smeal, Goldie Eckley, David Millinder and Walter Shaw on the East; said proposed road being 932 feet in length and 20 feet in width and ending at the southern property line of Walter Shaw.

And unless exceptions are filed to the aforementioned report of the Supervisors of the Road District of the Township of Boggs within 30 days from the date of the filing thereof, the same will be confirmed absolutely by the Court.

REPORT OF BOARD OF SUPERVISORS OF THE
ROAD DISTRICT OF THE TOWNSHIP OF
BOGGS, CLEARFIELD, COUNTY, PENNSYLVANIA

TO THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE OF SAID COURT:

We, the undersigned duly elected and qualified Supervisors of the Road District of the Township of Boggs, Clearfield County, Pennsylvania, upon the Petition of the property owners affected and other parties in interest, requesting that the Supervisors of Boggs Township take over, as a part of the general road system of the Township of Boggs, a private road long since in existence and used by the general public, the said road being hereinafter more specifically described, and in conformity with the provisions of the Act of Assembly of July twentieth, 1953, P.L. 511, (P.S. 53, Section 19093-1101 and 1102) in such case made and provided, do hereby make a report as follows:

(1) That your undersigned Board of Supervisors of the Road District of the Township of Boggs, Clearfield County, Pennsylvania, pursuant to the provisions of the Act of Assembly of 1953, P.L. 511, Section 1102 (a) (53 P.S. 19093-1102) (a), gave ten (10) days written notice to the property owners affected thereby, namely: General Refractories Company, West Decator, Pennsylvania, Heddy Goss, West Decator, Pennsylvania, David Godisart, West Decator, Pennsylvania, John Bordas, West Decator, Pennsylvania, George Mease, West Decator, Pennsylvania, Raymond Smeal, West Decator, Pennsylvania, Leonard Kyler, West Decator, Pennsylvania, Walter Smeal, West Decator, Pennsylvania, Goldie Eckely, West Decator, Pennsylvania, David Millinder, West Decator, Pennsylvania, and Walter Shaw, West Decator, Pennsylvania, that a meeting or hearing would be held at the West

Decator School Building, West Decator, Pennsylvania, on Saturday, the 7th day of May, A.D., 1955, 7:30 o'clock P.M., for the purpose of determining the advisability and necessity of taking over said proposed road as a part of the general road system of the Township of Boggs, a copy of said notice being hereto attached and made a part hereof and marked Exhibit "A".

(2) That pursuant to said notice a meeting was held at the West Decator School Building, West Decator, on Saturday, May 7, 1955 at 7:30 o'clock P.M., when the following appearances were noted: Earl W. Smeal, Burton Davis, Williard R. Millner, Supervisors of the Road District of the Township of Boggs, together with Lorraine Hinchliffe, Secretary of the Boggs Township Road District, also Heddy Goss, David Godisart, John Bordas, George Mease, Raymond Smeal, Leonard Kyler, Walter Shaw, Goldie Eckely and Rosa Millinder, Petitioners and parties in interest, all of whom were sworn and examined by the Board of Supervisors of the Township of Boggs. There being but one objection to said proposed road by one of the abutting property owners, namely: that on the part of George Mease of West Decator, Pennsylvania.

(3) That said proposed road lies wholly within the Township of Boggs, Clearfield County, Pennsylvania, and extends over a private road which has long since been in existence and used by the general public, the same being described as follows:

Beginning at the intersection of Township Road Route 674 in the Township of Boggs and proposed road at the General Refractories Company ~~Property~~ in West Decator, Pennsylvania; thence extending in a southerly direction along the course of said proposed road which abutts the Tyrone-Clearfield Branch of the Pennsylvania Railroad Company on the West and the lands of the General Refractories Company, Heddy Goss, David Godisart, John Bordas, George Mease, Raymond Smeal, Leonard Kyler, Walter Smeal, Goldie Eckely, David Millinder and Walter Shaw on the East, said proposed road having a total length of nine hundred thirty-two (932) feet and twenty (20) feet in width and ending at the southern property line of Walter Shaw.

(4) That your undersigned Board of Supervisors, after hearing on said Petition and investigation made of this matter and said Board being of the opinion that said proposed road is necessary

for the accommodation and convenience of the traveling public, by virtue of the powers vested in them under the aforementioned acts of assembly, by resolution of your undersigned Board of Supervisors unanimously adopted at a special meeting held on the 20th day of May, 1955, passed an Ordinance for the laying out, opening and taking over of the aforementioned proposed road as part of the general road system of the Township of Boggs, a copy of said Ordinance being hereto annexed and made a part hereof and marked Exhibit "B". Also attached and made a part hereof is a copy of the hand bills posted at conspicuous places along said proposed road within ten (10) days after the passage of said Ordinance as required by law, marked Exhibit "C".

(5) That attached hereto and made a part hereof is a draft or survey of said proposed road that has been passed and accepted by resolution and Ordinance, duly adopted by your undersigned Supervisors of Boggs Township as a part of the general road system of said Township, showing the location of said proposed road, its over all length to be 932 feet and the width 20 feet as authorized by law, the fixed termini thereof and the property owners affected thereby.

(6) That attached hereto and made a part hereof is the Petition presented to your undersigned Supervisors of Boggs Township, requesting that the above described road be taken over as a part of the general road system of the Township of Boggs; together with releases obtained from the owners or abutting property owners of the land through which said proposed road will pass, as shown by the accompanying blue print or sketch of said proposed road hereto attached.

WHEREFORE, your undersigned Board of Supervisors of the Road District of the Township of Boggs respectfully prays your Honorable Court to confirm this report ni. si. and that confirmation thereof be made absolute by the Clerk of the Court of Quarter Sessions of Clearfield County, Pennsylvania, as of course, unless

exceptions are filed to this report within thirty (30) days from
the ni. si. confirmation thereof, as authorized by law.

AN ORDINANCE ESTABLISHING AND OPENING A PUBLIC ROAD IN THE
TOWNSHIP OF BOGGS, COUNTY OF CLEARFIELD AND
STATE OF PENNSYLVANIA

BE IT ORDAINED, and it is hereby enacted and ordained
by the Board of Supervisors of the Township of Boggs, County of
Clearfield and State of Pennsylvania, as follows:

SECTION 1. A Township Road is hereby established and
opened and made a part of the general road system of the Township
of Boggs.

Beginning at the intersection of Township Road
Route 674 in the Township of Boggs and proposed
road at the General Refractories Company Property
in West Decator, Pennsylvania; thence extending
in a southerly direction along the course of
said proposed road which abutts the Tyrone-
Clearfield Branch of the Pennsylvania Railroad
Company on the West and the lands of the General



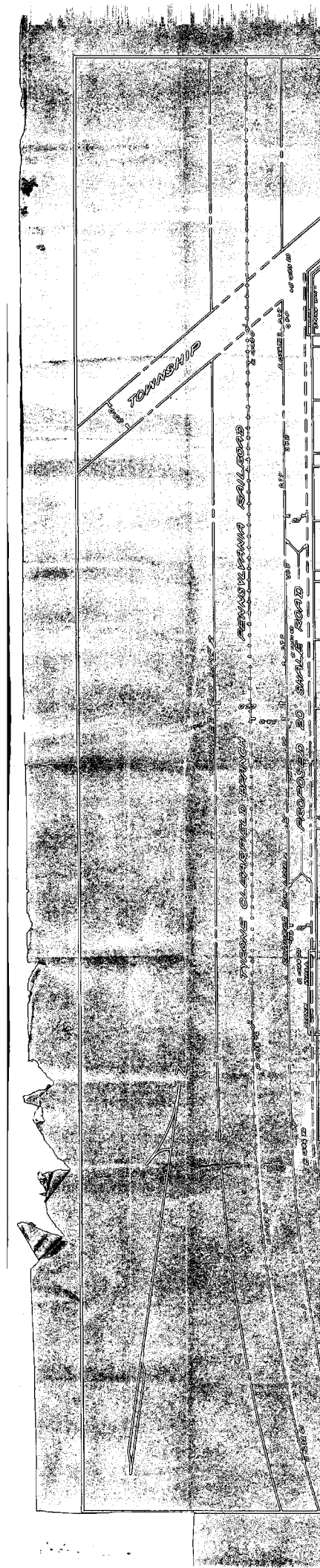

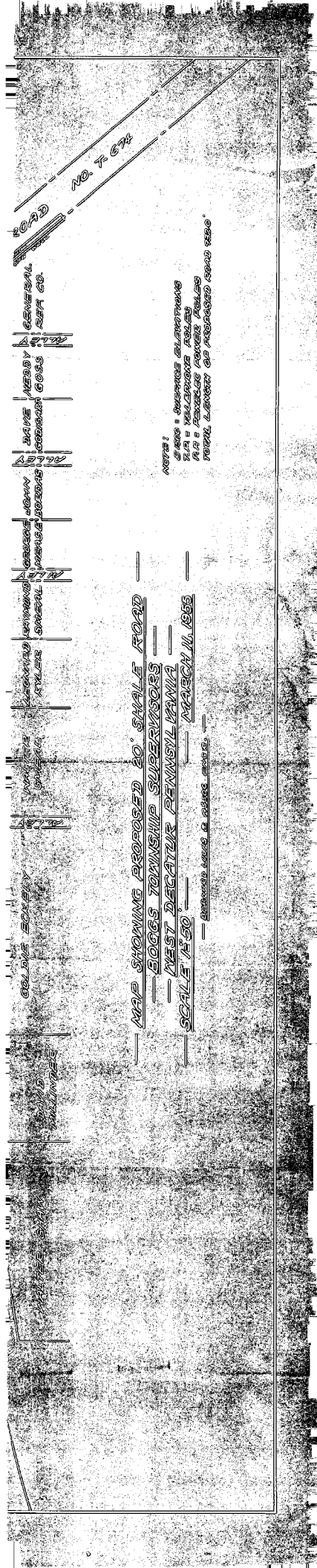
