## ARTICLES OF INCORPORATION

BE IT KNOWN, that the undersigned, all of whom are residents of the Commonwealth of Pennsylvania and citizens of the United States, and all of whom are of full age, having associated themselves together for the purpose of organizing The Temple Baptist Church of DuBois, Pennsylvania, and being desirous of becoming incorporated in accordance with the provisions and requirements of the Act of the General Assembly of the Commonwealth of Pennsylvania known as the "Non-profit Corporation Law," approved May 5, 1933 as amended, do hereby declare, set forth and certify as follows:

1. That the name of the Corporation is The Temple Baptist Church of DuBois, Pennsylvania, and that said name has been registered with the Department of State within six months of the date of the application for this charter.

2. That the location and Post Office Address of its initial registered office in this Commonwealth is City of DuBois, County of Clearfield, and State of Pennsylvania.

3. The purpose or purposes of the Corporation are:

(a). The primary purpose for which the Corporation is organized is to promote religious, moral, educational, missionary and evangelistic work, in accordance with the practice of a regular Baptist Church.

(b). To acquire, purchase, lease and encumber the necessary real property to be used in connection with the objects of this Corporation, and to erect necessary buildings thereon, and to do the things requisite or desirable to carry out the objects of said Corporation.

(c). To receive, own, and dispose of cash and securities to be used from time to time for the development of interests of this Corporation.

(d). To have a common seal and alter the same at pleasure, and to take into possession and custody all the temporalities of the church, and to make the rules and regulations for the management thereof, whether the same shall consist of real or personal estate, and whether the same shall have been given, granted or bequeathed or devised directly or indirectly to said church or to any person for its use.

(e). To bargain, sell, convey, mortgage or release any real estate belonging to said church or held by them as trustees, and to erect churches, parsonages, school houses, and other buildings for the direct and legitimate use of said church, and to alter and repair the same, and to fix the salary of its minister or ministers (if at any time there be more than one) or to anyone in its employ.

(f). To do each and everything necessary, suitable and proper for the accomplishment of any one or more of the purposes hereinbefore enumerated or conductive to or expedient for the interests or benefits of the Corporation.

The foregoing statement of purposes shall be construed as both a statement of purposes and powers and the purposes and powers stated in each clause, except where otherwise expressed, are in no wise limited or restricted by reference to or inference from the terms and provisions of any other clause, but shall be regarded as an independent purpose, and all for the primary object of carrying out the purposes and principles of the Baptist faith.

4. The term of its existence is perpetual.

7. The Articles of Incorporation or the By-Laws adopted in conformity herewith may be amended by the adoption of a resolution by the Board of Directors or Trustees, and the vote or written assent of a majority of the members entitled to vote.

8. That it is a Corporation which is not formed for pecuniary gain and does not contemplate pecuniary gain or profit to the members thereof, and no revenue received or derived from the activity or operation of the Corporation is to inure to the benefit of any individual.

9. The property is irrevocably dedicated to religious, charitable, scientific or hospital purposes and upon the liquidation, dissolution or abandonment of the owner will not inure to the benefit of any private person except a fund, foundation or Corporation organized and operated for religious, hospital, scientific or charitable purposes.

10. That this Corporation is organized on a Non-stock basis.






THERE is much value in the advice given to mature women that says: find what suits you and stick to it.
