TO THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE:

PETITION PRAYING FOR ADOPTION OF  
HALL STREET AS PART OF LAWRENCE  
TOWNSHIP ROAD SYSTEM

The Petition of Joseph W. Young, George W. Carns, and  
Bryon Peoples respectfully represents:

(1). They are the duly elected members of the Board of  
Supervisors of Lawrence Township, a municipal subdivision of  
Clearfield County, Pennsylvania.

(2). On the recorded plan of the Steel & Iron Works Addi-  
tion to the Borough of Clearfield, which said plan is recorded  
in Miscellaneous Book S, page 515, and which was recorded on  
September 16, 1902, there is shown a street or roadway extending  
in a southeasterly direction from where the same intersects with  
Washington Avenue running toward the railroad right-of-way of the  
Buffalo, Pittsburgh & Rochester Railroad Company, which said plan  
is incorporated herein by reference.

(3). For over twentyone years prior to the date of the  
hereinafter referred to resolution, and commencing sometime after  
1902, said Hall Street or the hereinafter designated portion  
thereof has, from time to time, been used as a public thoroughfare  
as a means of access to and from properties abutting the same.

(4). The aforesaid plan of the Steel & Iron Works Addition  
to the Borough of Clearfield operated as a dedication of Hall Street  
for public use.

(5). Recent industrial and other development in and about  
the vicinity of Hall Street, and more particularly that portion  
thereof hereinafter described, has made it to the best interest  
of the Township to accept the dedication of said Hall Street as  
hereinafter described in order that the interests of the property

owners abutting the same might be properly protected.

(6). Under the provisions of the Second Class Township Code, 53 P.S. 19093-101 et seq., your Petitioners have the power to accept by resolution any roads, streets or alleys as public road if dedicated to such use.

(7). At a regular meeting of the Board of Supervisors of Lawrence Township, your Petitioners, held in Lawrence Township on July 2, 1957, the following resolution was adopted:

WHEREAS, there is designated on the maps of the Steel & Iron Works Addition to the Borough of Clearfield, as recorded in the office of the Recorder of Deeds in and for Clearfield County, in Miscellaneous Book S, page 515, a certain street thereon designated as Hall Street; and,

WHEREAS, the aforesaid map of the Steel & Iron Works Addition to the Borough of Clearfield was recorded in Clearfield County on September 16, 1902; and,

WHEREAS, there is nothing among the existing records of the Board of Supervisors of Lawrence Township which would indicate that said Hall Street or any portion thereof, and the dedication thereof to public use has been accepted by the proper municipal authorities; and,

WHEREAS, it is to the best advantage of the surrounding property owners and Lawrence Township that a portion of said Hall Street be accepted and adopted as part of the Lawrence Township Road System; and,

WHEREAS, the authority to adopt dedicated roads is vested in the Board of Supervisors of Lawrence Township by virtue of the provisions of the Second Class Township Code.

NOW, THEREFORE, BE IT RESOLVED, that the following described portion of Hall Street be and is hereby adopted as part of the road system of Lawrence Township:

ALL that certain piece or parcel of land situate in the Village of Hyde, Lawrence Township, Clearfield County, Pennsylvania, the same as appears on the recorded map of the Steel & Iron Works Addition to the Borough of Clearfield, as recorded in Miscellaneous Book S, page 515 on September 16, 1902, and so much thereof as follows:

BEGINNING at a point on the South right-of-way line of State Highway No. 17098 (shown as Washington Ave. on the Steel & Iron Works Addition map); thence South 58 degrees east 296 feet. Being at all times a right-of-way sixty feet in width.

Being the same premises as shown on the attached blueprint.

Now, Therefore, your Petitioners pray your Honorable Court that your Honorable Court approve the acceptance of Hall Street as designated above, and issue an Order authorizing the same to be added to the road system of the said Lawrence Township.

And they will ever pray.




