RESOLUTIONS OF THE SUPERVISORS OF

BRADY TOWNSHIP

Versus

RESOLUTION

WHEREAS, the Commonwealth of Pennsylvania has improved and relocated certain portions of State Route 862-7 in Brady Township, Clearfield County, Pennsylvania;

AND WHEREAS, the Commonwealth of Pennsylvania has vacated certain portions of said route, for a new location, and said vacation is in favor of Brady Township;

AND WHEREAS, the Brady Township is desirous of vacating certain portions there of, so that the same shall revert to the owners of the surface across which the vacated lot exists;

NOW THEREFORE, it is

RESOLVED

That portions of State Highway Route 862-7, as existing prior to December 29, 1955, being that portion from Stations 1 + 54 to 25 + 50, 1 + 71 to 25 + 80, 55 + 00 to 71 + 00, 55 + 25 to 71 + 84, are hereby abandoned and vacated by Brady Township, and all rights of the said Brady Township in and to the rights of way under which the above location existed are abandoned, and in favor of the present surface owners of land of which said abandoned right of way might exist.

AND FURTHER, that that portion of State Highway Route 862-7 from Stations 76 + 00 to 91 + 00, 76 + 94 to 93 + 93, which have been abandoned by the Commonwealth of Pennsylvania shall be and are hereby retained by Brady Township, and no rights are relinquished in and to said portions.

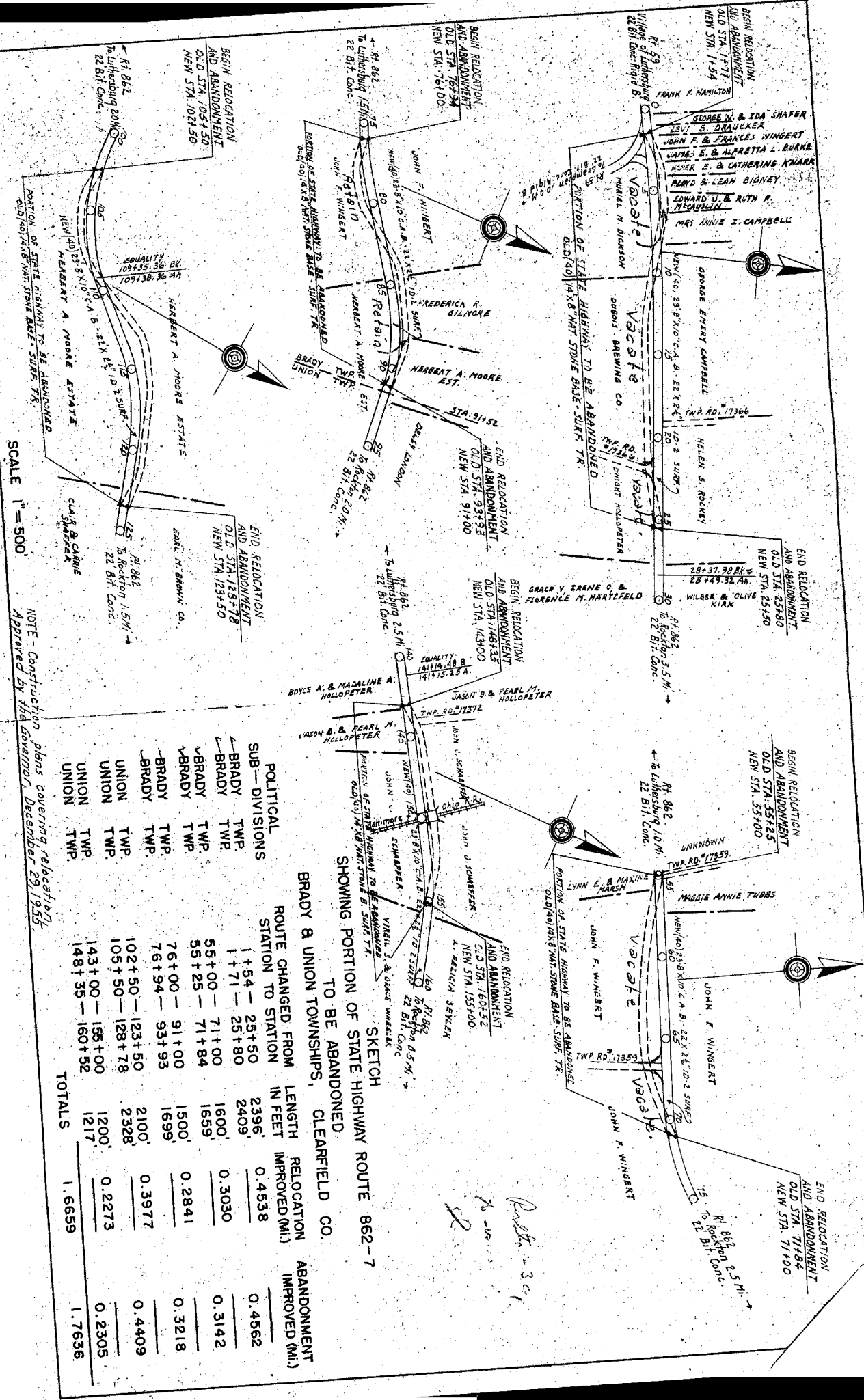
