PETITION FOR DEDICATION
OF A STREET

WHEREAS, the undersigned are the owners of the tracts of land herein mentioned and dedicated as public thoroughfares, as well as the owners of all the lots adjoining and abutting on said tracts; and petition and desire that the Township of Morris shall accept the hereinafter described road as a public thoroughfare of Morris Township, Clearfield County, Pennsylvania, to be incorporated into the system of township highways; NOW,

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned of Morris Township, Clearfield County, Pennsylvania, in consideration of the benefits accruing to the land owned by us, do hereby and by these presents remise, release, quit-claim and forever discharge Morris Township, Clearfield County, Pennsylvania, or the Road Supervisors of said township of and from all manner of damages, actions or accounts for or on account of the ordaining and accepting as a public thoroughfare of the hereinafter described thoroughfare, hereby dedicating the same to the said Township of Morris, Clearfield County, Pennsylvania, for public use as a street subject to said township Resolutions and Regulations, the following described thoroughfare, a plan thereof being attached hereto and made an integral part of this Petition and the following description, to wit:-

ALL that certain roadway or street located in Morris Township, Clearfield County, Pennsylvania, and hereafter to be known as "Club Street" bounded and described as follows:

BEGINNING at a point in the exact center of the Southern boundary of the intersection of State Highway Route No. 17103 and township highway 685 and extending therefrom East and West equidistant from said center point sixteen and one-half (16 $\frac{1}{2}$) feet East and West of said center point and center line for a distance of seven hundred feet, more or less, for a uniform width of thirty-three (33) feet along the courses and distances shown on the map attached hereto and made an integral part hereof, to the Northern boundary of the intersection of township road No. 683 and township road No. 690.
