P E T I T I O N

The Petition of the Huston Township Supervisors respectfully represents:

(1). That the undersigned are the duly elected Supervisors of Huston Township, Clearfield County, Pennsylvania.

(2). That in the year 1940 The Pennsylvania Department of Highways abandoned certain sections of State Highway Route 17092, within Huston Township, between Station 172.87 and 191.77, the same being curves that were eliminated in the improvement of the said State Highway.

(3). That the said abandoned sections of State Highway reverted to the care of the Huston Township Supervisors.

(4). That two sections of ~~said~~ abandoned State Highway, containing approximately eight hundred feet of roadway in the two sections, lie on the property of the Whitney Realty Corporation located approximately one-half way between Home Camp and Johnston's Nursery.

(5). That the Supervisors of Huston Township deem it advisable to vacate said sections of abandoned State Highway, as the same is unnecessary for the convenience of the public and the upkeep is a needless expense to the citizens of Huston Township.

(6). That the Supervisors of Huston Township have agreed with the Whitney Realty Corporation, the only property owner affected, that the aforesaid sections of abandoned State Highway shall be vacated and a joinder in the prayer of this Petition executed by Frank J. Hahne, Jr., as president of Whitney Realty Corporation, is attached hereto and made a part hereof.

WHEREFORE, the Supervisors of Huston Township respectfully pray your Honorable Court that the aforesaid abandoned sections of State Highway Route 17092 be vacated in accordance with 1933, May 1, P. L. 103, art. XI, sec. 1115; 1947, July 10, P. L. 1481, sec. 17; 1956, June 1, P. L. (1955) 2021, sec. 16 (53 P. S. 66115).




