PETITION

The petition of Jos. W. Young, Byron Peoples, and Harry Baney respectfully represents:

1. That they are the duly elected Supervisors of Lawrence Township, Clearfield County, Pennsylvania.
2. A dedication of a 20 foot strip by A. L. Moore, Sr., et al by written declaration of 17, November, 1953, made of a 20 foot strip and a 13 foot strip to the west of said dedication has been in use from time to time for over 21 years.
3. Said road is located wholly within Lawrence Township and is 33 feet in width and further described as follows:

BEGINNING at a point on the south right-of-way line of Pennsylvania State Highway #17040; said point being located 0.8 miles west of Clearfield Borough and 1.5 miles east of the Village of Hyde thence; by lands of Susquehanna Terrace on the east and lands of Jury, Kindig, Mitchell, Manos on the west the following courses and distances: south 60° degrees 55' minutes west 833.5 feet to the end. The above courses and distances being on the center line of road and the said road having a right-of-way width of 33 feet. The easterly edge of said road shall commence at and be bounded on the westerly line of the division of land known as Susquehanna Terrace and to extend in a westerly direction from said westerly edge of Susquehanna Terrace a distance of 33 feet.

4. The acceptance of said road would be a benefit to the public and to Lawrence Township.

5. Attached hereto and made a part hereof is a certified copy of a Resolution duly passed by the Board of Supervisors of Lawrence Township accepting said road and also a plan of said road.

WHEREFORE, your petitioners request that your Honorable Court consent to the acceptance of Norris Street as a part of the public road system of Lawrence Township, by endorsing your consent hereto.

Young, Byron Peoples, and Harry Baney, Supervisors of Lawrence Township, Clearfield County, Pennsylvania requesting consent to the acceptance of Norris Street as more fully described in petition and its attached description as a part of the road system of Lawrence Township having been reviewed and considered and it appears to this Court that the acceptance of the same would be a benefit to the public and to Lawrence Township.

IT IS hereby ORDERED, ADJUDGED AND DECREED that the said road shall be hence forth a part of the road system of Lawrence Township.

BEGINNING at a point on the south right-of-way line of Pennsylvania State Highway #17040; said point being located 0.8 miles west of Clearfield Borough and 1.5 miles east of the Village of Hyde thence; by lands of Susquehanna Terrace on the east and lands of Jury, Kindig, Mitchell, Manos on the west the following courses and distances: south 60° degrees 55' minutes west 833.5 feet to the end. The above courses and distances being on the center line of road and the said road having a right-of-way width of 33 feet. R E S O L U T I O N

ADOPTING AND ACCEPTING STREET SITUATED IN LAWRENCE TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA TO BE KNOWN AS NORRIS STREET

WHEREAS, A. L. Moore, Sr., Mille L. Moore and A. L. Moore, Jr. has by a written dedication dated 17th day of November, 1953, dedicated for public use a portion of land described as follows:

Bounded on the North by Coal Hill Road being Route #17040, on the west by lane or road fronting on or being part of properties of George B. Maines, John Mitchell, Roy C. Kindig, Jr., and Alice Yaworsky, on the south by other land of the Moores' and on the east by Susquehanna Terrace. Said parcel being twenty (20) feet in width and extending along the western side of subdivision known as Susquehanna Terrace, plan of which is recorded in the office of the Recorder of Deeds in File #2 and,

WHEREAS, a strip of land 13 feet in width has for 21 years and longer lying to the west of said above dedication been open to and subject to public travel and,

WHEREAS, the owners of said 13 foot strip have petitioned Supervisors of Lawrence Township to take over said strip and,

WHEREAS, it would be to the advantage of the property owners and the public in general to have said road in the total width of 33 feet as a part of the road system of Lawrence Township.

BE IT RESOLVED THEREFORE THAT the road hereinafter designated being 33 feet in width be and is hereby accepted as a township road subject to the consent of the Court of Quarter Sessions of Clearfield County, Pennsylvania and to be known as

NORRIS STREET

Beginning at a point on the south right-of-way line of Pennsylvania State Highway #17040; said point being located 0.8 miles west of Clearfield Borough and 1.5 miles east of the Village of Hyde thence; by lands of Susquehanna Terrace on the

east and lands of Jury, Kindig, Mitchell, Manos on the west the following courses and distances: south 60° degrees 55' minutes west 833.5 feet to the end. The above courses and distances being on the center line of road and the said road haveing a right-of-way width of 33 feet. The easterly edge of said road shall commence at and be bounded on the westerly line of the division of land known as Susquehanna Terrace and to extend in a westerly direction from said westerly edge of Susquehanna Terrace a distance of 33 feet.

Ordered, enacted and passed this 3rd day of April, 1958.


