P E T I T I O N

The petition of the Supervisors of Penn Township,
Clearfield County, Pennsylvania, duly represents:

1. That the undersigned are the duly elected Supervisors
of Penn Township, Clearfield County, Pennsylvania.

2. That Township Route No. 472 from the Pennsylvania
Railroad tracks at Stronach, Pennsylvania, to the old route of
State Highway No. 322 lies across the lands of Lemoyne Wrigglesworth
and Jessie B. Wrigglesworth in a low area which increases drainage
problems and causes the road to drift shut in times of heavy snow.

3. That the Supervisors of Penn Township, Clearfield
County, Pennsylvania, and Lemoyne Wrigglesworth and Jessie B.
Wrigglesworth have agreed that the Supervisors of Penn Township
shall relocate the aforesaid section of Township Route No. 472
so that the new route of the said Township road shall consist of
a thirty-three (33) foot right of way along the eastern boundary
line of the property of Lemoyne Wrigglesworth and Jessie B.
Wrigglesworth as shown on the sketch attached hereto and made a
part hereof.

4. That the Supervisors of Penn Township, Clearfield
County, Pennsylvania, and Lemoyne Wrigglesworth and Jessie B.
Wrigglesworth have agreed that Lemoyne Wrigglesworth and Jessie B.
Wrigglesworth shall give to Penn Township the thirty-three (33)
foot right of way along the eastern line of the Wrigglesworth
property for the new relocation of Township Route No. 472 and the
old location of the said route across the Wrigglesworth property
shall be vacated.

5. That attached hereto and incorporated herein by reference is a release of all claims for damages by reason of the relocation of Township Route No. 472, executed by Lemoyne Wrigglesworth and Jessie B. Wrigglesworth.

6. That the proposed new location of Township Route No. 472 will improve the drainage of said route and largely eliminate the problem of drifting snow.

WHEREFORE, the Supervisors of Penn Township, Clearfield County, Pennsylvania respectfully pray your Honorable Court that the old route of Township Route No. 422 across the land of Lemoyne Wrigglesworth and Jessie B. Wrigglesworth be vacated and the new location of the said route be designated on the sketch attached hereto and made a part hereof in accordance with 1933, May 1, P.L. 103, art. XI, sec. 1115; 1947. July 10, P. L. 1481, sec. 17; 1956, June 1, P. L. (1955) 2021, sec. 16 (53 P.S. 66115),

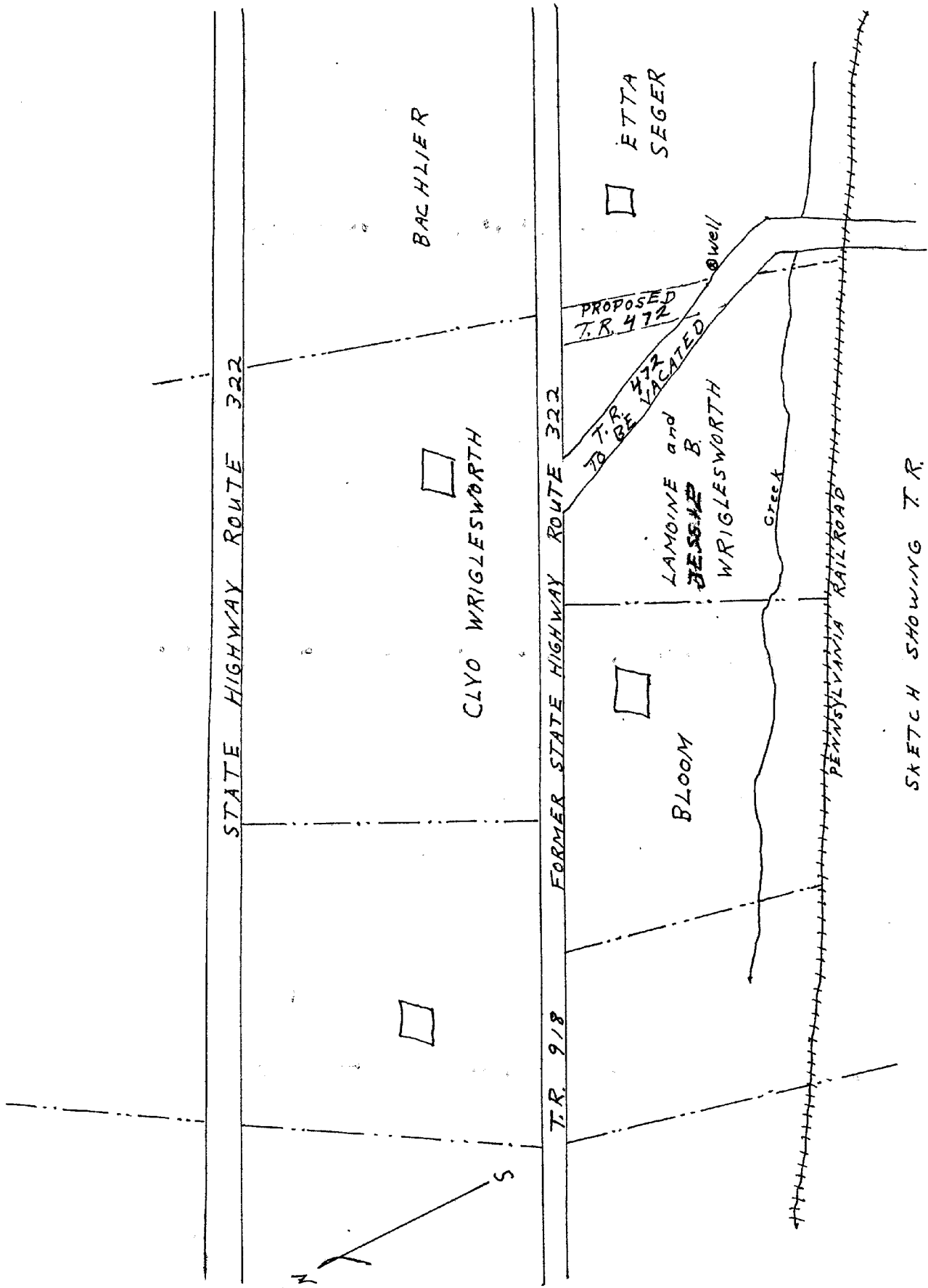



NOW, this 25 day of April, 1958, the within petition having been read and considered and appearing that the Supervisors of Penn Township, Clearfield County, Pennsylvania, are desirous of relocating a portion of Township Route No. 472 lying upon the land of Lemoyne Wrigglesworth and Jessie B. Wrigglesworth, and it further appearing that Lemoyne Wrigglesworth and Jessie B. Wrigglesworth have agreed with the Supervisors of Penn Township that the section of Township Route No. 472 lying upon and crossing their land shall be vacated and relocated as shown on the sketch attached to the within petition and as said Supervisors deeming such relocation advisable and petition having been presented to this Court under the Act of 1933, May 1, P. L. 103, art. XI, sec. 1115; 1947, July 10, P. L. 1481, sec. 17; 1956, June 1, P. L. (1955) 2021, sec 16 (53 P. S. 66115). NOW THEREFORE, it is hereby ordered and decreed that so much of Township Route No. 472 as lies on the property of Lemoyne Wrigglesworth and Jessie B. Wrigglesworth be vacated and relocated as a thirty-three (33) foot right of way on the eastern boundary on the property of Lemoyne Wrigglesworth and Jessie B. Wrigglesworth as shown on the sketch attached to the within petition.
