I N D E N T U R E

THIS INDENTURE, made the 27th day of July, one thousand nine hundred and fifty-nine (1959) between the BOROUGH OF WESTOVER, a municipal corporation in the County of Clearfield and State of Pennsylvania, of the one part,

ROSS WESTOVER of the Borough of Westover, County of Clearfield and State of Pennsylvania, and his assigns of the other part;

WITNESSETH, that the said Ross Westover for and in consideration of the sum of TEN (\$10.00) DOLLARS, lawful money of the United States, unto him well and truly paid by the said Borough of Westover, at and before the sealing and delivery hereof, the receipt whereof is hereby acknowledged unto the said Borough of Westover, its assigns, the free and uninterrupted use, liberty and privilege of, and passage in, over and along a certain road-way or right-of-way over and across a certain piece or parcel of land owned by Ross Westover which is set forth fully in Deed Book Volume 474 page 25, records of Clearfield County, Pennsylvania.

Said road-way or right-of-way presently existing and in use, being a twenty-four (24) foot right-of-way with a fourteen (14) foot road-way and five foot burm on each side thereof. Said road-way crossing the Ross Westover property from state highway route leading from the Borough of Westover to the Borough of Irvona and thence across grantor's premises at about the midway point therein.

TOGETHER with free ingress, egress and regress to and for the said Borough of Westover to be used by the said Borough as a Borough Thoroughfare or roadway for the use of the public, its assigns, its or their tenants and under tenants, occupiers or possessors to the said roadway or right-of-way to be used as a public road at all times and seasons for ninety-nine (99) years as of the above date, into, along, upon, and out of the said right-of-way.

TO HAVE AND TO HOLD all the singular, the privileges aforesaid to the said Borough of Westover and its assigns for the afore-

said length of time.

The said Borough of Westover at its regular meeting assembled held on the 6th day of April, 1959, approved this Indenture and authorized the President to execute and acknowledge this Indenture on its behalf, attested thereto by its Secretary and the Borough Seal affixed thereon.


