

PARTIAL RELEASE

To all to whom these presents shall come, the Department of Public Welfare of the Commonwealth of Pennsylvania, whose address is 229 Walnut Street, P. O. Box 182, Harrisburg, Pennsylvania, sends greetings.

WHEREAS, the said Department of Public Welfare did obtain a judgment against Thomas W. Gouldthread, now deceased, entered in said County March 22, 1940 to No. 343 May Term, in the amount of \$2,000.00 that at the time said Thomas W. Gouldthread was the owner of a certain tract of land comprising approximately 0.27 acres, situate in Clearfield County, Greenwood Township, Pennsylvania, and;

WHEREAS, the said Department of Public Welfare did revive said Judgment to No. 446, May Term, against the heirs of Thomas W. Gouldthread and again revived said judgment to No. 236, November Term, December 12, 1960, and;

WHEREAS, ^{qf} Thomas Gouldthread (a/k/a T. W. Gouldthread) was on March 22, 1940 the owner of a certain tract of land situate in Clearfield County, Greenwood Township, Pennsylvania, and;

WHEREAS, since the rendition of said judgment, a portion of the aforesaid mentioned property comprising 0.27 of an acre, a complete description of which is attached hereto and made a part hereof by reference, has become presently vested in Clarence Bracken and Marjorie Bracken, his wife, who have agreed to convey to the United States of America, for a consideration of FIFTY DOLLARS (\$50.00), a perpetual flowage easement in said 0.27 of an acre to be used in connection with the Curwensville Reservoir Project and for the purposes of said Project said land has been designated as Tract 601-E, and;

WHEREAS, in order for the United States of America to acquire a free and clear title, the said Department of Public Welfare has been requested to release the lien of said judgment insofar, and in so far only as it affects the perpetual easement interests to be acquired by the United States of America in the said Tract 601-E.

NOW, THEREFORE, know ye that the Department of Public Welfare of the Commonwealth of Pennsylvania, as well in consideration of the premises as of the sum of ONE DOLLAR (\$1.00) lawful money to it paid by Clarence Bracken and Marjorie Bracken, his wife, the owners of said Tract 601-E, at the time of the execution hereof, the receipt whereof is hereby acknowledged, have remised, released, quitclaimed, exonerated and discharged, and by these presents does remise, release quitclaim, exonerate and discharge unto the said Clarence Bracken and Marjorie Bracken, his wife, their heirs and assigns all that perpetual easement interest only to be conveyed to the United States of America by deed dated 29th day of JANUARY 1962 and recorded in Deed Book _____ at page _____ in the following described tract of land designated for the purposes of the Curwensville Reservoir Project as Tract 601-E, a copy of which description is attached hereto and made a part hereof by reference: _____

TRACT 601-E
LEGAL DESCRIPTION

A certain tract of land situate in the State of Pennsylvania, Clearfield County, Greenwood Township and more particularly bounded and described as follows:

Beginning at the intersection of the 1233 foot contour above mean sea level U. S. C. & G. S. Datum with the line common to the lands of James P. Dickey, et ux and lands of Clarence Bracken, et ux and being 75 feet, more or less, from the beginning of the sixth or South 87° 36' East, 193 feet, line of lands described in a deed from Myles Anderson to Clarence Bracken and Marjorie Bracken dated August 17, 1957 and filed for record in Deed Book 462 Page 262 of the Clearfield County land records, said point being located North 22° 15' East 2620 feet, more or less, from the intersection of the centerline of United States Highway route number 219 with the centerline of State Highway 969; thence from said point of beginning following generally the meanders of said 1233 foot contour and severing the lands of said Bracken the following courses and distances:

North 08° 31' 51" West 37.83 feet
North 48° 22' 00" East 60.21 feet
North 27° 28' 28" East 112.71 feet
South 81° 15' 14" East 13.51 feet to the intersection of said 1233 foot contour with the line common to the lands of said Bracken and lands of Patricia Ann Perry Lang and to a point in the centerline of Bell Run; thence leaving said 1233 foot contour and along the land of said Lang and along the approximate centerline of said run the following courses and distances:

South 07° 29' 46" West 38.33 feet
South 07° 10' 39" East 136.07 feet to a corner common to the lands of said Dickey and lands of said Bracken; thence leaving the lands of said Lang and the center of said run and along the lands of said Dickey,
South 88° 48' 46" West 116.42 feet to the place of beginning, containing 0.27 of an acre, more or less.

The bearings used herein are referenced to the Pennsylvania State Rectangular Grid System (North Zone) - 1927 N. A. Adjustment.

The above described tract is a part of the same land as that described in a deed from Myles Anderson to Clarence Bracken and Marjorie Bracken dated August 17, 1957 and filed for record September 23, 1957 in Deed Book 462 Page 262 in the records of Clearfield County, Pennsylvania.

Gouldthread, or the remedies at law for recovering thereout or against the said heirs of Thomas W. Gouldthread, the remainder of the principal sum, with interest, of the said judgment.


