(3). From July 11, 1950 to December 2, 1960, Defendants were the owner of a tract of land situate in Decatur Township, Clearfield County, Pennsylvania, which they acquired by Deed dated July 11, 1950 and which is recorded in Deed Book 408 page 57. The property is bounded and described as follows:

(4). On the 13<sup>th</sup> day of November, 1959, the Plaintiff did enter a judgment on a warrant of attorney contained in a sealed obligation from the Defendant to Plaintiff in the amount of \$2,340.00, and which was filed to No. 77 November Term, 1959.

(5). On September 2, 1960, the land was sold on execution upon the judgment averred in Paragraph (4) and the land was purchased by Plaintiff.

(6). On the 2nd day of September, 1960, the Sheriff of Clearfield County executed and delivered a Deed to the land to Plaintiff, and Plaintiff paid the purchase price of \$3,895.00, and Plaintiff's deed is recorded in Clearfield County Deed Book , page

(7). The Defendant, however, remains in possession of the land and refused to relinquish the same unto Plaintiff, the rightful owner.

WHEREFORE, under Rule 1066 (b) (4) of the Rules of Civil Procedure, the Court is requested to issue an Order directed to the Sheriff to oust the Defendant of possession of said premises and deliver the same to Plaintiff, and assess the costs of such recovery against the Defendant.
