COMPLAINT

1. The Plaintiff, John R. Crago, Inc., is a corporation organized under the laws of the Commonwealth of Pennsylvania, with its main office and principal place of business located at 412-420 Latimer Street, Clearfield Borough, Clearfield County, Pennsylvania.

2. The Defendant, Floyd Martell, is an individual residing in the Village of LeContes Mills, Girard Township, Clearfield County, Pennsylvania.

3. The Plaintiff is engaged in the business of distributing petroleum products.

4. That from December 30, 1958 to May 9, 1959, at the oral request of the defendant, the plaintiff sold and delivered to the defendant gasoline and other petroleum products as shown by the statement and invoices attached hereto, marked Exhibit "A" and made a part hereof.

5. That there is presently due the plaintiff the sum of \$873.82 and the defendant has failed, refused or neglected to pay this amount or any part thereof since May 9, 1959 in spite of frequent demands made by the plaintiff upon the defendant that the same be paid.

6. That the prices charged the defendant are the prices at which the plaintiff sold the same kind and amounts of gasoline and other petroleum products to its other customers and are reasonable.

WHEREFORE, there is due the plaintiff from the defendant the sum of \$873.82 with interest from May 9, 1959 and the entry of judgment against the defendant, Floyd Martell, for that amount is requested.

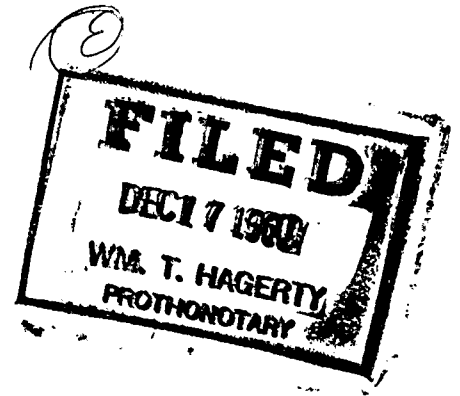
