

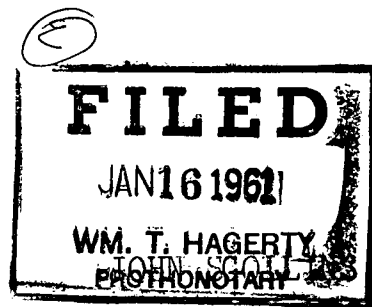

PETITION TO APPEAL FROM ORDER OF SECRETARY OF REVENUE SUSPENDING
OPERATOR'S LICENSE

To The Honorable John J. Pentz, President Judge of said Court:

The petition of Cleo Wayne Pentz respectfully represents:

1. That the Secretary of Revenue of the Commonwealth of Pennsylvania, on a date unknown to your petitioner, entered an order, suspending your petitioner's operator's license for a term of two (2) months, beginning December 19, 1960.
2. That your petitioner received, on December 14, 1960, an "Official notification of withdrawal of motor vehicle privileges," with instructions to immediately return to the Department of Revenue his operator's card, plate No. 5996590.
3. That the only reason assigned by the Department of Revenue for its action in suspending petitioner's driving privileges was "Convicted of speeding in the State of Indiana which would be a violation of §1002-(b) 2 of the Pennsylvania Motor Vehicle Code.
4. That there is considerable merit to your petitioner's reason for appeal which should be heard by your Honorable Court and under the Act of 1929, P. L. 58, §620 (75 P. S. 620) the law affords your petitioner the privilege of appealing for a hearing

in the matter in the Court of Common Pleas of the County in which the operator resides.

WHEREFORE, your petitioner prays that an appeal be granted to him from the order of the Secretary of Revenue, which appeal would act as a supersedeas in accordance with the Act of 1959, P. L. 58, §620, (75 P. S. 620).


