Sessions of the County of Clearfield

The petition of the undersigned, inhabitants of the
Townships of Bradford and Boggs in said County, res=
pectfully represents

That the line between the Townships of Bradford
and Boggs in said County, as now established, is so lo=
cated, that several families are deprived of the ben=
efit of a school, in the Township of Bradford, and that the
convenience of those families, would be greatly promoted,
in that respect, by altering the lines between said Town=
ships as follows, viz: That the track of Bradford Township

known as the Reynold Kean be included within the Township
of Boggs for school purposes - so that those living upon said
track of land may be allowed to send to the school within the
Township of Boggs, school being now committed to said land
so to be included as aforesaid. We therefore pray you honor=
able present suitable persons to view said proposed change
and report the same to your honorable Court & they will
as in duty bound pray &c.

A Court of Quarter Sessions of Clearfield County, held at Clearfield in and for said county on the day 17th day of June A.D. 1868, before the Judges of said court upon the petitions of many inhabitants of the Townships of Bradford & Boggs, setting forth that they labour under great inconveniences for want of a change of the Township lines for school purposes, do as to include the tract of land in Bradford known as the Reynold's Place to be included in Boggs Township, for school purposes. And therefore praying the court to appoint proper persons to view said line according to law.

Whereupon the court upon due consideration had of the premises, do order and appoint Wm. D. Bigler, James H. Lamm, and Wilson Hoover, who after being duly sworn or affirmed to perform the duties of their appointment, with impartiality & fidelity, are to view said line, and if any two of them agree that there is occasion for such change shall make report thereof with a plan or draft thereof with the reasons and distances of the same and report to the next court of Quarter Sessions to be held for the County aforesaid.

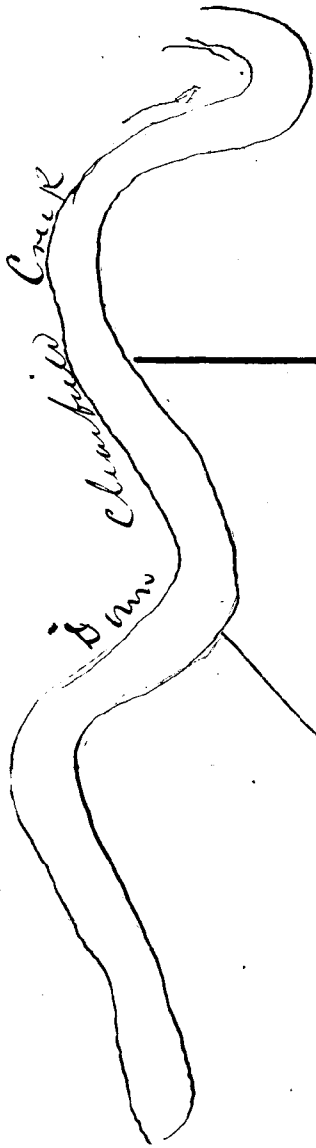

To the Court of Quarter Sessions of
Chapin County

The undersigned appointed by the
aforesaid order of Court for the purposes then
mentioned, Respectfully report

That having given ~~them~~ ^{the} notice in
accordance with the Act of Assembly of the
time & place of their meeting, they met at the
house of Wilson Haver in Boggs Township on the
17th day of July 1868 and have been sworn and
affirmed to perform the duties assigned to them
by said order with fidelity, and having viewed
the lines of Bradford & Boggs Township, proposed
to be changed, ~~they~~ ^{they} are of the opinion that the
line of the said Bradford & Boggs Township
should be so far changed as to place the
survey known as the Reynold Kean survey
in Boggs Township for school purposes.

^{& a small part of the Reynold Kean survey}
the line of which survey are as follows: Begin-
ning at the South East corner of the Reynold Kean survey, then South
along the boundary to the North East corner of Reynold Kean, then West
to Chapin Creek then up the creek to original township line & corner of Wilson
Haver, and then along said tp line by Reynold Kean survey to the place of beginning
a draft or plot of which is hereto annexed.

The undersigned further report that the changes
of the township line in accordance with the line
above mentioned - placing the Reynold Kean
survey in Boggs Township - ^{& a small part of the Reynold Kean survey} for school purposes
would be to the convenience of the ^{persons} ~~inhabitants~~ living
on said survey, and they believe there is occasion
for such change: and that the prayer of the
petitioners should be granted.
