COMPLAINT

And now comes JOHN ALAN PIFER, WILLIAM J. PIFER and WILLIAM L. PIFER, trading as G. W. PIFER SONS, and by their attorneys Gleason, Cherry & Cherry, files this Complaint in Assumpsit against Joe DeSalve and Marie DeSalve, husband and wife, defendants, upon a cause of action whereof the following is a statement.

1. The plaintiffs, John Alan Pifer, William J. Pifer, and William L. Pifer, partners, trading as G. W. Pifer Sons, are dealers in lumber, millwork and builders supplies, and are residents of DuBois, Clearfield County, Pennsylvania.

2. The defendants, Joe DeSalve and Marie DeSalve, husband and wife, are individuals and reside at Penfield, Clearfield County, Pennsylvania.

3. The plaintiffs, at DuBois, Pennsylvania, at the special instance and request of the defendants, sold and delivered to the defendants lumber and building supplies, at the times, in the amounts, of the kinds, and for the prices, set forth in a true and correct copy of account taken from the plaintiff's books of original entry hereto attached and marked Exhibit "A".

4. The prices charged for said lumber and building supplies are just and reasonable, and are prices which the defendants promised to pay plaintiffs for the same.

5. The plaintiffs have demanded payment from the defendants of the amount due, but the defendants have refused and still refuse to pay the same, or any part thereof.

WHEREFORE, plaintiffs demand judgment against the defendants for the sum of \$1,103.31, with interest from the 18th day of June, 1959.




