of errors and with ten per cent Attorney's Commission.

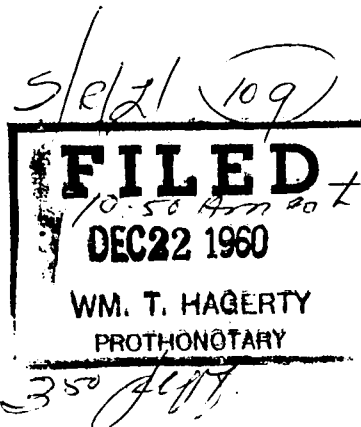
