C O M P L A I N T

NOW COMES the Plaintiff, by her attorney, JOHN B. GATES, and brings this Complaint in Divorce against the above named MILES EARL PELTON, JR. upon a cause of action, whereof the following is a statement:

1. The name of the Plaintiff is MARINA DANGANAN PELTON, whose residence is c/o Mrs. Ping de Benito, 4858 Druid Los Angeles 32, California.
2. The name of the Defendant is MILES EARL PELTON, JR., a resident of Winburne, Cooper Township, Clearfield County, Pennsylvania, and temporarily residing at 318 Second Street, Marisal Village, Angeles, Pampanga, Philippines.
3. The Defendant is a resident of the Commonwealth of Pennsylvania and has been a bona fide resident of Clearfield County, Pennsylvania for more than one year.
4. The Plaintiff and the Defendant were married April 16, 1947 before Justice of the Peace of Makati, Rizal.
5. That the following named child was born to this marriage and is presently residing with the Defendant:

Marilyn Pelton, age 12 years.

6. The Defendant has:


a. By cruel and barbarous treatment endangered the life of the Plaintiff, who is the innocent and injured spouse.

b. The defendant has committed adultery prior to the separation of the Plaintiff and the Defendant and continues to live with another woman in adultery, other than his wife, in the Republic of the Philippines.

7. That there is no collusion between the Plaintiff and the Defendant regarding this action.

8. The Defendant has heretofore applied for a divorce at No. 713 May Term, 1960 in the Court of Common Pleas of Clearfield County, Pennsylvania and also has filed an Action in the Court of First Instance of Pampanga, Fifth Judicial District, Branch No. 2 , Civil Case No. 1846, for Declaration of Nullity of Marriage.

WHEREFORE, the Plaintiff respectfully prays your Honorable Court that she be granted an absolute divorce, separating herself from the said MILES EARL PELTON, JR., the Defendant, as if she had never been married, or as if the said Defendant were naturally dead.
