(T.V., V.C.R., Microwave) I told him they would ruin left in the rain, he said "SO what," "I have Kurt (Curry) to help me with it right now". Then I talked him into letting me call my brother to see if he could come from Port Matilda on Sunday meet us at Dennis's apartment at 4:PM, I called him back & told Dennis my brother could meet us on Sunday & he <sup>(brother)</sup> would help carry appliances down the stairs. Then I told him I did not want to go to dinner or make love to him (We were supposed to go Sunday 01/02/00 night). He started cussing & I hung up phone - he immediately called me right back & said, "O.K. Sunday at 4:PM is O.K."... Approx. 2:30 pm (same day) Dennis called me at work and told me "I'll burn you & the dog up in the camper & I won't have to worry about this "f.ing" divorce if you're dead". I hung up on Dennis

## QUESTION 7 (most recent incident of abuse) CONTINUED:

and called Clearfield<sup>psp</sup> police - they said to call Punxy. (So I did) I wrote a statement to Trooper Louis Davis & attempted to get a P.F.A. But with the holiday weekend I would have to come back into town & refile for one when the Court House was opened. I had talked to Cross Roads Project in Punxy on Saturday, 01/01/00, Taisha said to think about & call back on Sunday. When I called back on Sunday I was told the Court house would be opened on Monday, so I waited & I am<sup>01/03/00</sup> now at the Cross Roads project in Clearfield getting help with all of this.



QUESTION 8 (most recent incident of abuse) CONTINUED: #4-add.

8. B) At the end of Aug. 99 Dennis was drunk and we fought at the Apartment, He fired a shot from a 9mm pistol at (or near to scare me) my feet. He Kicked me & pushed me down, the Pwxy. State Police has pictures ~~off~~ of my leg bruises & Dennis was charged with Harassment.
- C) On ~~the 4th~~ <sup>99</sup> Halloween at my mothers in OH Dennis drank all day at the neighbors house. We had a nasty verbal argument then.
- D) On the 4th of July <sup>99</sup> Dennis left finger prints on my arms from pushing me (my mother had seen them & cussed Dennis out).
- E) On our <sup>11/01/97</sup> Wedding Reception Dennis was drunk ~~enough~~ enough to have a verbal fight with me in front of our guests
- F) Dennis has told me he is cancelling me off of all medical & auto Insurances & prescriptions (I pay my own Auto Ins. & Auto Loan).

AND NOW, this 4th day of January, 2000, (ISD) upon consideration of the attached Petition for Protection From Abuse, the Court hereby enters the following TEMPORARY ORDER:

- ( X ) 1. The Defendant shall refrain from **abusing, harassing, and threatening** the Plaintiff and the minor child(ren) or placing her/him/them in fear of abuse in any place where she/he/they may be found.
- ( ) 2. Defendant shall not threaten or harass a member of the Plaintiff's family or household.
- ( X ) 3. Plaintiff is granted exclusive possession of the residence where she/he resides which is located at:

- ( X ) 4. Defendant is prohibited from having any contact with Plaintiff at any location, including but not limited to any contact at Plaintiff's school, business, or place of employment.
- ( X ) 5. Defendant is restrained from making any communication with the Plaintiff, including but not limited to, personal, written or telephone contact, or others with whom the communication would be likely to cause annoyance or alarm the Plaintiff.

- ( ) 6. Pending the outcome of the final hearing in this matter, Plaintiff is awarded temporary custody of the following minor child(ren):

The local law enforcement agency in the jurisdiction where the child(ren) are located shall ensure that the child(ren) are placed in the care and control of the Plaintiff in accordance with the terms of this Order.

- ( X ) 7. Defendant is prohibited from possessing and/or purchasing a firearm or other weapon. Defendant shall immediately relinquish the following weapons to the local law enforcement agency for delivery to the Sheriff's Office:

- ( X ) 8. The following additional relief is granted: DEFENDANT SHALL NOT POSSESS OR CONSUME ALCOHOL.

- ( X ) 9. A COPY OF THIS ORDER SHALL BE SERVED ON THE LAW ENFORCEMENT AGENCY WHERE PLAINTIFF RESIDES AND ANY OTHER AGENCY SPECIFIED HEREFTER:

- ( ) 10. THIS ORDER SUPERSEDES [ ] ANY PRIOR PFA ORDER AND [ ] ANY PRIOR ORDER RELATING TO CHILD CUSTODY.

#### **NOTICE TO THE DEFENDANT**

Defendant is hereby notified that violation of this Order may result in arrest for Indirect Criminal Contempt, which is punishable by a fine of up to \$1,000.00 and/or up to six months in jail. 23 Pa.C.S. Section 6114. Consent of the Plaintiff to Defendant's return to the residence shall not invalidate this Order, which can only be changed or modified through the filing of appropriate court papers for that purpose. 23 Pa.C.S. Section 6113. Defendant is further notified that violation of this Order may subject him/her to state charges and penalties under the Pennsylvania Crimes Code and to federal charges and penalties under the Violence Against Women Act, 18 U.S.C. Sections 2261-2262.

#### **NOTICE TO LAW ENFORCEMENT OFFICIALS**

THIS ORDER SHALL BE ENFORCED BY THE POLICE WHO HAVE JURISDICTION OVER THE PLAINTIFF'S RESIDENCE 'OR' ANY LOCATION WHERE A VIOLATION OF THIS ORDER OCCURS 'OR' WHERE THE DEFENDANT MAY BE LOCATED. IF DEFENDANT VIOLATES ANY PROVISIONS OF THIS ORDER, DEFENDANT SHALL BE ARRESTED ON THE CHARGE OF INDIRECT CRIMINAL CONTEMPT. AN ARREST FOR VIOLATION OF THIS ORDER MAY BE MADE WITHOUT WARRANT, BASED SOLELY ON PROBABLE CAUSE, WHETHER OR NOT THE VIOLATION IS COMMITTED IN THE PRESENCE OF LAW ENFORCEMENT.

WEAPONS MUST FORTHWITH BE DELIVERED TO THE SHERIFF'S OFFICE OF THE COUNTY WHICH ISSUED THIS ORDER, WHICH OFFICE SHALL MAINTAIN POSSESSION OF THE WEAPONS UNTIL FURTHER ORDER OF THIS COURT, UNLESS THE WEAPON(S) ARE EVIDENCE OF A CRIME, IN WHICH CASE, THEY SHALL REMAIN WITH THE LAW ENFORCEMENT AGENCY WHOSE OFFICER MADE THE ARREST.
