PETITION FOR BLOOD TEST

David Martell, through his Attorney, Paul Colavecchi, Esquire, files this Petition, and respectfully avers as follows:

1. Petitioner moves this Court for an Order pursuant to 23 Pa. C.S.A. 5104, requiring the parties to submit to a physical examination for the purpose of ascertaining blood type and blood subtype to assist the Court in determining the paternity of the child referred to by comparison of blood types.

2. Petitioner would show there is a controversy between he and Respondent to the paternity of the child referred to.

3. The names of the parties are as follows:

Petitioner is David Martell;

Respondent is April Harvey; and the

Child is Jonathan Harvey.

4. The child, Jonathan Harvey, was born on November 9, 1996.

5. Petitioner, David Martell, was not made aware of the fact he was the father until he received notice by mail in approximately February, 1998 that Respondent filed for child support.

6. The blood testing will not result in an undue burden upon the parties because of the unique circumstances in the case.

7. Respondent did not initially acknowledge the Petitioner as the father, but rather had his brother, Robert Martell, submit to a blood test for paternity in 1997. This blood test proved that Robert Martell was not the father of the child, Jonathan Harvey.

8. Petitioner may not be stopped from seeking a blood test to determine paternity for the following reasons:

- a. He is not a presumptive parent;
- b. He was never married to Respondent;
- c. He has never acknowledged the child as his own;
- d. He has never held himself out as the father of this child;
- e. He has never lived with the child;
- f. He has never supported the child; and
- g. He has never seen the child.

WHEREFORE, Petitioner requests that both he and Respondent be ORDERED by this Court to appear at a time and place appointed by the Court for the purpose of submitting to a blood examination.




