
AND NOW, the 23 day of May, 2000, the Plaintiff and Defendant having filed Affidavits of Consent stating that the marriage is irretrievably broken and that ninety (90) days have elapsed from the date of the service of this Complaint and Waivers of Notice of Intention to Request Entry of Divorce Decree having been filed;

We, therefore, DECREE that JENNIFER LYNN HARRIS, be divorced and forever separated from the nuptial ties and bonds of matrimony heretofore contracted between herself and PAUL ALLEN HARRIS. Thereupon all the rights, duties or claims accruing to either of said parties in pursuance of said marriage, shall cease and determine, and each of them shall be at liberty to marry again as though they had never been heretofore married.
