**C O M P L A I N T**

6. That there has been no prior action for divorce or annulment instituted by either of the parties in this or any other jurisdiction.


7. That the marriage is irretrievably broken.






Paragraphs 1 through 12 are incorporated by reference as though the same were set forth at length herein.
