





9. The said Kevin Hainsey agrees to this name change and has executed the Consent that is attached hereto as Exhibit "A."


10. The family of the natural father of the said child has failed to show any interest in the child and has had no contact with him since the natural father's death in 1990.



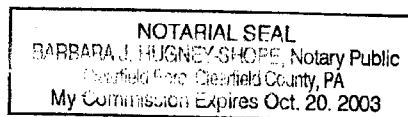
