

COMPLAINT FOR ANNULMENT

1. The Plaintiff is Edward D. Stonebraker who currently resides at 613 West Front Street, Clearfield, Clearfield County, Pennsylvania.

2. The Defendant is Robyn Marie Stonebraker a/k/a Robyn Marie Padgett, with a residence in Kerr Addition, Clearfield, Clearfield County, Pennsylvania. It is believed and therefore averred that at present the defendant is incarcerated at the Clearfield County Jail, Clearfield, Pennsylvania.

3. Both Plaintiff and defendant have resided within the Commonwealth of Pennsylvania for more than six months immediately prior hereto.

4. The parties were married on June 13, 1998.

5. It is believed and therefore averred that on March 17, 1985, the defendant married one, William Homer Padgett, in New York State.


6. On June 13, 1998, the defendant entered into the marriage with the plaintiff when the aforesaid marriage to William Homer Padgett had not been annulled, nor had there been a divorce or any termination of said marriage contract.

8. There has been no confirmation by cohabitation or other acts by the plaintiff subsequent to the removal of the impediment to the marriage.

WHEREFORE, plaintiff requests that the alleged marriage between him and the defendant be deemed null and void, and that the court enter a Decree of Annulment.


