

AND NOW, comes Petitioner, Public Credit, LLC, by and through its counsel of record, Theron G. Noble, Esquire, of Ferraraccio & Noble, who avers as follows in support of its MOTION TO PERMIT DISTRIBUTION:

1. These matters concern distribution of funds realized through judicial sale of Defendant Cougar Contracting's assets, forced by Plaintiffs as a result of various judgments placed against said Defendant.
2. Such assets were previously pledged by the Defendant to Petitioner as security for a loan.
3. Petitioner intervened believing it was lawfully entitled to the proceeds of such sales, amounting to \$1,001.
4. The Court agreed, as evidenced by its opinion and Order dated December 5, 2000, but requested Petitioner to produce evidence that the proceeds of such sale would not entirely satisfy Defendant's obligation to Petitioner.
5. Attached hereto, as Exhibit "A", is an Affidavit of Petitioner's General Manager, Peter C. Varischetti, verifying that Defendant was in fact indebted to Petitioner in the amount of \$534,248.14 such that the proceeds would not satisfy Defendant's obligation to Petitioner.

WHEREFORE, Petitioner requests that the Sheriff be
ORDERED to deliver the \$1001.00 being held from such sales to
Petitioner.



proposed \$1001.00 distribution in these matters.

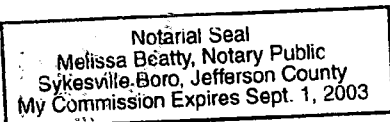
