


4. On the dates set forth below, the Plaintiff provided hauling services as set forth:



PRELIMINARY OBJECTIONS

1. Plaintiff, James Yaworski, Jr., served civil complaint on defendant, Daniel Stiles for Hawk Logging. That case is captioned above.
2. The basis for the complaint is an oral contract for plaintiff to haul timber for Hawk Logging, which the latter allegedly breached.
3. Paragraph 2 of plaintiff's complaint states that defendant Daniel Stiles, t/d/b/a Hawk Logging, has an address of R.R.3, Box 260-3, Reynoldsburg, Pennsylvania 15851. That is in Jefferson County.
4. Paragraphs 3 and 4 of plaintiff's complaint lists the locations where the contract was performed as being Punxsutawney to Big Run and Brookville to Big Run. All three (3) are located in Jefferson County.
5. Rule 1006(a) of Pennsylvania Rules of Civil Procedure states that: "an action may be brought in and only in a county in which the individual may be served or in which the cause of action arose or where a transaction or occurrence took place out of which a cause of action arose ...". That is Jefferson County.
6. Defendant seeks to have the case captioned transferred to the Court of Common Pleas of Jefferson County.

WHEREFORE, the defendant requests that Your Honorable Court enter an order directing that this case be transferred to Jefferson County.




