

1. Petitioner is Joseph Colavecchi, an individual who is licensed to practice law in the Commonwealth of Pennsylvania and is a shareholder of Clearfield Bank & Trust Company whose mailing address is 221 East Market Street, Clearfield, Pennsylvania 16830.

2. Respondent is Clearfield Bank & Trust Company, a banking corporation organized and existing under the laws of the Commonwealth of Pennsylvania, having its principal place of business at 11 North Second Street, Clearfield, Pennsylvania 16830.

4. Petitioner, as a stockholder of Respondent corporation, desires to have access to the books and records of Respondent corporation and particularly the records of the stockholders showing

their names, addresses, and number of shares held as of the date of filing this Petition.

5. On April 19, 2000, Petitioner made a written demand upon Respondent corporation, directed to William E. Wood, President of Clearfield Bank & Trust Company. A copy of the demand marked Exhibit 1 is attached hereto and incorporated herein by reference.

6. Earlier, Petitioner had asked for a copy of the shareholder list by letter dated January 27, 2000, a copy of which is attached hereto, marked Exhibit 2, and incorporated herein by reference.

7. William E. Wood delivered what was allegedly the list of the shareholders of Clearfield Bank & Trust Company.

8. The list of shareholders supplied to Joseph Colavecchi did not include the number of shares held by each shareholder.

9. After Petitioner utilized the shareholder list, he discovered that a number of shareholders were not contained in the list as supplied to him and notified William E. Wood by letter dated March 9, 2000, a copy of which is attached hereto, marked Exhibit 3, and incorporated herein by reference.

10. Petitioner was supplied with a new list of shareholders as of March 8, 2000.

11. Recently, Petitioner shareholder has reason to believe that he does not have the up-to-date and complete list of shareholders and for this reason made a demand on William E. Wood

as President of Clearfield Bank & Trust Company for an updated list.

12. In response, Petitioner received a letter from William T. Harvey, Attorney for Clearfield Bank & Trust Company, refusing to allow Petitioner to examine the shareholders' list and books and records of Clearfield Bank & Trust Company. A copy of the letter dated April 27, 2000, marked Exhibit 4, is attached hereto and incorporated herein by reference.

13. It was and is the intention of Petitioner to contact all of the shareholders of Clearfield Bank & Trust Company and to ask if 20 percent of them are interested in demanding a special meeting of shareholders to vote to rescind certain bylaws which were adopted in the Fall of 1999 which give the Board of Directors the authority to discourage any tender offer by a third party for the shares of Clearfield Bank & Trust Company.

14. By reason of the refusal of Respondent corporation to permit Petitioner to examine the books of Respondent corporation, Petitioner is unable to obtain the names and addresses of the shareholders and to determine their number of shares so as to contact them as a fellow shareholder and Petitioner has no adequate remedy at law. None of the shareholder lists supplied to Petitioner showed the number of shares held by each shareholder.

WHEREFORE, Petitioner prays for an Order requiring Respondent to show cause why a peremptory Writ of Mandamus should not issue

requiring Clearfield Bank & Trust Company to permit Petitioner or Petitioner's duly authorized representative to examine and inspect the books and records of Clearfield Bank & Trust Company and Petitioner is further asking that attorney's fees be awarded to him for the cost of preparing this Petition and filing it with the Court and handling the hearing.





Dear Mr. Colavecchi:

Bill Wood of Clearfield Bank & Trust Company has forwarded to me your most recent correspondence to shareholders dated April 11, 2000 and your correspondence to Mr. Wood dated April 19, 2000. Mr. Wood has asked me to respond to you directly regarding both letters.

Your April 11th letter to shareholders continues to refer to the fact that Clearfield Bank & Trust Company has adopted a "poison pill". It hasn't.

A poison pill is a plan which grants small shareholders the right to buy a significant number of common shares below market price if a large shareholder purchases shares exceeding a certain specified percentage of shares. The board hasn't granted any such right to its shareholders. Your statements to the contrary are misleading.

You continue to make such misleading statements even after we have notified you in our earlier letter to shareholders that a poison pill has not been adopted. As counsel, we will be advising the Board of Directors that they may challenge the validity of any proxies that are solicited based on intentionally misleading statements.

In light of the above, we suggest that you consider either amending your information or dropping your efforts to solicit proxies on these issues.

The Board's primary goal is to increase profitability and shareholder value. The Board presently feels that this can best be done by enhancing the bank's future prospects as an independent entity. Without increased earnings and the resulting increase in shareholder value no sale of the bank could bring an acceptable return to the shareholders.

In response to your letter of April 20th, management of Clearfield Bank & Trust Company has decided not to send you an updated shareholder list. The Pennsylvania Banking Law does not require us to send updated shareholder lists upon request. Our earlier mailing of the shareholder list to you was made in the spirit of cooperation in anticipation of the annual meeting. Since there is no requirement to send you an updated list and since the annual meeting is past, management does not feel it is necessary or appropriate to provide you with an updated list.


