PETITION FOR CHANGE OF NAME

The Petitioner, TROY MATTHEW CLOUSER, through his undersigned Counsel, requests that this Court order a change of name for him pursuant to 54 Pa. Cons. Stat. §701 et seq., and in support thereof represents as follows:

1. The Petitioner, TROY MATTHEW CLOUSER, is a resident of R. R. 2, DuBois, Pennsylvania, which is in Sandy Township. He has resided in the following locations during the five years next preceding the filing of this Petition:

From a period of 8 years until approximately 3 years ago, in DuBois, PA, at 524 Burt Street.

From that time until present at R. R. 2 (10 Country Place) DuBois, PA 15801, which is in the Sabula area of Sandy Township.

2. The Petitioner, TROY MATTHEW CLOUSER, is an adoptee, having been born on March 17, 1975.

3. Petitioner was adopted by Timothy Clouser on or about August 22, 1980. At that time, Timothy Clouser was married to Petitioner's natural mother, but they are now divorced, and she has remarried her prior husband, and the natural father of your Petitioner, Daniel Knisely, of 222 Brown Street, Reynoldsville, PA 15851.

4. Petitioner's name on his original Birth Certificate,

prior to the adoption above mentioned, was Troy Matthew Knisely.

5. Because Petitioner wishes that his name reflect his true identity and heritage, and because his natural parents have remarried, and because of his desire to have any children or any other descendants bear his true name, Petitioner desires to be known as TROY MATTHEW KNISELY.

6. Petitioner has never married, nor does he have any children fathered by him born at this time, although his fiancee, Heidi Keth, is pregnant to him, and a child is due on or about June 26, 2000.


7. His desire to change his name is not induced by fraud or intent to cause injury or confusion.


